**COMPLAINT**

The Investigative Committee of the Board of Medical Examiners of the State of Nevada, composed of Charles N. Held, M.D., Chairman, Cindy Lamerson, M.D., Member, and Ms. Jean Stoess, M.A., Member by and through Edward O. Cousineau, Deputy General Counsel for the Nevada State Board of Medical Examiners, having a reasonable basis to believe that Harriston L. Bass, Jr., M.D., hereinafter referred to as "Respondent," has engaged in conduct that is grounds for discipline pursuant to the provisions of Nevada Revised Statutes (NRS) Chapter 630, hereby alleges, charges and complains against said Respondent as follows:

1. Respondent was licensed to practice medicine in the state of Nevada on December 7, 1985 by the Nevada State Board of Medical Examiners, pursuant to the provisions of Chapter 630 of the NRS. On June 16, 2006, the Nevada State Board of Medical Examiners summarily suspended Respondent's license to practice medicine in the state of Nevada, and it remains suspended to date.

2. On or about December 19, 2006, a multiple-count criminal complaint was filed in Las Vegas Justice Court against Respondent charging him with various criminal conduct, including Sale of a Controlled Substance Causing Death, a Category A Felony, Sale of a Controlled Substance, a Category C Felony, Unlawful Possession for Sale of Substances Classified in Schedule III, a Category D

1 Felony, and Unlawful Possession for Sale of Substances Classified in Schedule IV, a Category D  
2 Felony.

3 3. On or about January 18, 2007, Respondent was arraigned in the Clark County District  
4 Court to address the aforementioned criminal charges. Respondent plead not guilty to all criminal  
5 counts and the matter was set for trial thereafter.

6 4. The criminal trial against Respondent began on February 25, 2008 and concluded on  
7 March 5, 2008, with a jury finding Respondent guilty of one count of Sale of a Controlled Substance  
8 Causing Death (Second Degree Murder), a Category A Felony, forty-nine counts of Sale of a Controlled  
9 Substance, all Category C Felonies, and six counts of Possession of a Controlled Substance for the  
10 Purpose of Sale, all Category D Felonies.

11 5. On or about April 22, 2008, Respondent was sentenced for conviction of the criminal  
12 counts specified in paragraph 4.

13 6. Thereafter, on or about May 6, 2008, a Judgment of Conviction related to the criminal  
14 sentencing was filed with the Clark County District Court (see Exhibit A).

15 **COUNT I**

16 7. All of the allegations in the above paragraphs are incorporated herein as if set forth in full.

17 8. Section 630.301(11)(a) of the Nevada Revised Statutes provides that a conviction of  
18 murder, voluntary manslaughter or mayhem is grounds for discipline.

19 9. Respondent violated Section 630.301(11)(a) when he was convicted of one count of Sale  
20 of a Controlled Substance Causing Death.

21 **COUNT II**

22 10. All of the allegations in the above paragraphs are incorporated herein as if set forth in full.

23 11. Section 630.301(11)(f) of the Nevada Revised Statutes provides that a violation of any  
24 state law regulating the possession, distribution or use of any controlled substance or dangerous drug as  
25 defined in Chapter 454 of the NRS is grounds for disciplinary action.

26 12. Respondent violated Section 630.301(11)(f) when he was convicted of Sale of a  
27 Controlled Substance and Possession of a Controlled Substance for the Purpose of Sale.

1           13.     By reason of the foregoing, Respondent is subject to discipline by the Nevada State Board  
2 of Medical Examiners as provided in NRS 630.352.

3           WHEREFORE, the Investigative Committee prays that the Nevada State Board of Medical  
4 Examiners conduct a hearing on the Complaint herein as provided by statute, find and determine that  
5 Respondent has violated one or more provisions of the Medical Practice Act (NRS Chapter 630), enter  
6 findings of fact, conclusions of law, and an order imposing sanctions upon Respondent according to NRS  
7 630.352 and take such other and further action as may be just and proper in these premises


