COMPLAINT

The Investigative Committee of the Nevada State Board of Medical Examiners, composed of Charles N. Held, M.D., Chairman, Jean Stoess, M.A., Member, and Benjamin Rodriguez, M.D., Member, by and through Lyn E. Beggs, General Counsel for the Nevada State Board of Medical Examiners, having a reasonable basis to believe that Charles Mahakian, M.D., hereinafter referred to as Dr. Mahakian, has violated the provisions of NRS Chapter 630, hereby issues its formal Complaint, stating the Investigative Committee's charges and allegations, as follows:

1. Dr. Mahakian is currently licensed in active status, and was so licensed by the Nevada State Board of Medical Examiners, hereinafter referred to as "the Board," on September 13, 1986 (License No. 5441), pursuant to the provisions of Chapter 630 of the Nevada Revised Statutes, and at all times addressed herein was so licensed.

2. Person A was a thirty-five year old female at the beginning of the matter in question. Her true identity is not disclosed to protect her privacy, but has been made known to Dr. Mahakian.

3. Person A was hired by Dr. Mahakian as a part time employee in his office. During the course of her employment, Person A asked Dr. Mahakian to refill a prescription of Prozac for her which Dr. Mahakian proceeded to do.



WHEREFORE, the Investigative Committee prays:

1. That the Nevada State Board of Medical Examiners fix a time and place for a formal hearing;
2. That the Nevada State Board of Medical Examiners give Dr. Mahakian notice of the charges herein against him, the time and place set for the hearing, and the possible sanctions against him;
3. That the Nevada State Board of Medical Examiners determine what sanctions it determines to impose for the violation or violations committed by Dr. Mahakian; and
4. That the Nevada State Board of Medical Examiners make, issue and serve on Dr. Mahakian its findings of facts, conclusions of law and order, in writing, that includes the sanctions imposed; and
5. That the Nevada State Board of Medical Examiners take such other and further action as may be just and proper in these premises.


