COMPLAINT

The Investigative Committee of the Nevada State Board of Medical Examiners, composed of Charles N. Held, M.D., Chairman, Jean Stoess, M.A., Member, and Benjamin J. Rodriguez, M.D., Member, at the time of the authorization of filing this formal complaint, by and through Edward O. Cousineau, counsel for the Investigative Committee, having a reasonable basis to believe that Phillip Lisagor, M.D., hereinafter referred to as "Respondent," has violated the provisions of NRS Chapter 630, hereby issues its formal Complaint, stating the Investigative Committee's charges and allegations, as follows:

1. Respondent was licensed to practice medicine in the state of Nevada on or about August 4, 1984. Respondent's license to practice medicine is currently active, and at all times alleged herein, Respondent was licensed in active status by the Nevada State Board of Medical Examiners, pursuant to the provisions of Chapter 630 of the Nevada Revised Statutes.

2. On or about March 21, 2008, while serving on active-military-duty and deployed to Southwest Asia, Respondent was issued an Article 15, or non-judicial punishment, under the Uniform Code of Military Justice in relation to previous events which brought Respondent's professional military conduct into question. At the time of the issuance of the Article 15, Respondent was afforded the opportunity to accept the disciplinary decision of the issuing body or to demand a trial by court martial.
