10                   **ORDER VACATING REMAINING TERM OF PREVIOUSLY ADOPTED**  
11                                   **SETTLEMENT, WAIVER AND CONSENT AGREEMENT**

12                   On August 11, 2009, a Settlement, Waiver and Consent Agreement (Agreement) between  
13 the Nevada State Board of Medical Examiners (Board) and Adrian Adrian, M.D. (Respondent)  
14 was filed with the Board. The Agreement contained various terms and conditions, all of which  
15 have been accomplished or satisfied by Respondent, with the exception that "Respondent will not  
16 perform any cosmetic medical procedures for a period of five years after the adoption of this  
17 Agreement."

18                   The Board received a request from Respondent, via his counsel, Kelly S. McIntosh, Esq.,  
19 that the remaining term to the Agreement be vacated, as the term is impacting Respondent's  
20 ability to obtain and maintain certification by the American Board of Family Medicine, thus  
21 impacting Respondent's employment opportunities.

22                   The aforementioned request came before the Board for consideration at its regularly  
23 scheduled meeting on March 8, 2013, at the Board's offices located at 1105 Terminal Way, Suite  
24 301, Reno, Nevada, 89502, and by video conference at the offices of the Nevada State Board of  
25 Dental Examiners located at 6010 S. Rainbow Boulevard, Building A, Suite 1,  
26 Las Vegas, Nevada 89118. Respondent was not present, but was represented by his counsel in  
27 Las Vegas.
