

1 13. NAC 630.380(1)(m) provides that a physician assistant is subject to disciplinary
2 action by the Board if the Board finds the physician assistant violated NRS 630.301 to 630.3065,
3 inclusive.

4 14. NRS 630.301(5) provides that the engaging by a practitioner in any sexual activity
5 with a patient who is currently being treated by the practitioner is grounds for initiating
6 disciplinary action against a licensee.

7 15. Respondent saw, treated and prescribed Phentermine to Patient A, while engaged in
8 a sexual relationship with Patient A in violation of NRS 630.301(5).

9 16. By reason of the foregoing, Respondent is subject to discipline by the Board as
10 provided in NAC 630.410.

11 **WHEREFORE**, the Investigative Committee prays:

12 1. That the Board give Respondent notice of the charges herein against her and give
13 her notice that she may file an answer to the Complaint herein as set forth in NRS 630.339(2)
14 within twenty (20) days of service of the Complaint;

15 2. That the Board set a time and place for a formal hearing after holding an
16 Early Case Conference pursuant to NRS 630.339(3);

17 3. That the Board determine the sanctions it will impose if it finds Respondent
18 violated the Medical Practice Act;

19 4. That the Board make, issue and serve on Respondent, in writing, its findings of
20 fact, conclusions of law and order, which shall include the sanctions imposed; and

21 5. That the Board take such other and further action as may be just and proper in these
22 premises.


