COMPLAINT

The Investigative Committee (IC) of the Nevada State Board of Medical Examiners (Board) comprised of, at the time of authorizing the filing of this Complaint, Theodore B. Berndt, M.D., Chairman, Valerie J. Clark, BSN, RHU, LUTCF, Member, and Michael J. Fischer, M.D., Member, by and through Bradley O. Van Ry, Esq., Board General Counsel and attorney for the IC, having a reasonable basis to believe that Syed Naeem Ahmed, M.D. (Respondent), has violated the provisions of Nevada Revised Statutes (NRS) Chapter 630 and Nevada Administrative Code (NAC) Chapter 630, collectively the Medical Practice Act (MPA), hereby issues its formal Complaint, stating the IC's charges and allegations, as follows:

1. Respondent's license to practice medicine in the state of Nevada (License No. 5158) is currently suspended, and Respondent was originally licensed by the Board on February 22, 1985.

2. A psychiatric evaluation of Respondent was recently performed to determine his ability to practice medicine with reasonable care and safety. The psychiatric evaluation found that Respondent cannot practice medicine with reasonable care and safety and that Respondent is not competent to practice medicine.






