

12 **ORDER EXTENDING SUMMARY SUSPENSION PENDING**  
13 **RESOLUTION OF FORMAL COMPLAINT**

14 The Nevada State Board of Medical Examiners (Board), by and through its Investigative  
15 Committee (IC), composed of Theodore B. Berndt, M.D., Chairman, Valerie J. Clark,  
16 BSN, RHU, LUTCF, Member, and Michael J. Fischer, M.D., Member, hereby orders the  
17 extension of the summary suspension of Kent Alan Swaine, M.D.'s (Dr. Swaine) license to  
18 practice medicine in the state of Nevada. This Order is made and based upon Nevada Revised  
19 Statute (NRS) 630.326, a review of the pleadings in this matter, and the Hearing Officer's  
20 synopsis and recommendations after a Board hearing on this matter.

21 Previously, Dr. Swaine's license to practice medicine in the state of Nevada was  
22 suspended by IC order on January 31, 2014. On February 5, 2014, the IC filed a formal  
23 Complaint against Dr. Swaine. The allegations contained in the formal Complaint arise out of,  
24 and/or are related to, the conduct that resulted in the summary suspension of Dr. Swaine's license  
25 to practice medicine in the state of Nevada. On July 14, 2014, a Board hearing addressing the  
26 propriety of continuing the summary suspension of Dr. Swaine's medical license was held before  
27 a Hearing Officer. Thereafter, the Hearing Officer's synopsis and recommendation after the  
28 hearing was submitted to the IC.
