

**ORDER REINSTATING LICENSE TO PRACTICE MEDICINE WITH**  
**RESTRICTION FROM PRACTICING GENERAL ANESTHESIA**

        The Investigative Committee (IC) of the Nevada State Board of Medical Examiners  
(Board), composed of Theodore B. Berndt, M.D., Valerie J. Clark, BSN, RHU, LUTCF, and  
Michael J. Fischer, M.D., after reviewing materials presented to it by Richard Alan Singer, M.D.  
(Dr. Singer), and after meeting with Dr. Singer, hereby reinstates Dr. Singer's license to practice  
medicine in the state of Nevada with the following restriction.

        1.     Dr. Singer may not practice general anesthesia, including, but not limited to,  
conscious sedation and/or deep sedation.

        2.     Dr. Singer will immediately notify the Board upon procuring employment as a  
physician, and provide the address, telephone number and email address of such place of  
employment pursuant to Nevada Revised Statutes (NRS) 630.254(2). Dr. Singer shall also  
immediately notify the Board upon any change in his place of employment, and immediately  
provide the new address, telephone number and email address of any new place of employment.

        3.     Should Dr. Singer fail to comply with any term or condition recited herein, the IC  
shall be authorized to immediately suspend Dr. Singer's license to practice medicine in the state of  
Nevada pending an order to show cause hearing, which will be duly noticed and scheduled.

1 Further, the IC may then have grounds, after notice and a hearing, to take disciplinary action  
2 against Dr. Singer, including, but not limited to, potential revocation of Dr. Singer's license to  
3 practice medicine in the state of Nevada and/or any other discipline authorized by NRS Chapter  
4 630 and Nevada Administrative Code Chapter 630.

5 4. The terms of this Order are effective the date the Order is filed.
