11 **ORDER OF SUMMARY SUSPENSION**

12 Prior to the preparation of this Order of Summary Suspension, Nevada State Board of
13 Medical Examiners (Board) staff presented evidence and information to an Investigative
14 Committee (IC) of the Board, composed of Theodore B. Berndt, M.D., Chairman,
15 Valerie J. Clark, BSN, RHU, LUTCF, Member, and Michael J. Fischer, M.D., Member, regarding
16 Syed Naeem Ahmed, M.D. (Dr. Ahmed). Upon review of the evidence and information presented
17 by Board staff, the IC hereby **IMMEDIATELY SUSPENDS** Dr. Ahmed's license to practice
18 medicine in the state of Nevada pursuant to Nevada Revised Statute (NRS) 630.326(1), based
19 upon the following preliminary findings:

20 1. Dr. Ahmed is a physician licensed to practice medicine in the state of Nevada
21 (License No. 5158) and was originally licensed on February 22, 1985. Dr. Ahmed lists his
22 specialty with the Board as Cardiothoracic.

23 2. A psychiatric evaluation of Dr. Ahmed was recently performed to determine his
24 ability to practice medicine with reasonable care and safety. The psychiatric evaluation found that
25 Dr. Ahmed cannot practice medicine with reasonable care and safety.

26 3. As a result of the recent psychiatric evaluation of Dr. Ahmed, the IC reasonably
27 determines and believes that the health, safety and welfare of the public is at imminent risk of

1 harm and that a summary suspension of Dr. Ahmed's license to practice medicine in the state of
2 Nevada is necessary to remove the risk of imminent harm to the health, safety and welfare of the
3 public.

4 Accordingly, pursuant to NRS 630.326(1):

5 **IT IS HEREBY ORDERED** that the license to practice medicine in the state of Nevada
6 of Syed Naeem Ahmed, M.D. (License No. 5158) is **HEREBY SUSPENDED** until further order
7 of the Investigative Committee or Board; and

8 **IT IS FURTHER ORDERED** that pursuant to NRS 630.326(2), a hearing on this matter
9 is set for the 21st day of February, 2014, at the Board's office located at 1105 Terminal Way,
10 Ste. 301, Reno, NV 89502, to determine whether this suspension may continue, unless the parties
11 mutually agree in writing to a divergent time frame.
