11 **ORDER OF SUMMARY SUSPENSION & NOTICE OF HEARING**

12 Prior to the preparation of this Order of Summary Suspension, Nevada State Board of
13 Medical Examiners (Board) staff presented evidence and information to an Investigative
14 Committee (IC) of the Board, composed of Beverly A. Neyland, M.D., Rachakonda D. Prabhu,
15 M.D. and Sandy Peltyn, regarding Ascar Egtedar, M.D. (Dr. Egtedar). Upon review of the
16 evidence and information presented by Board staff, the IC hereby **IMMEDIATELY SUSPENDS**
17 Dr. Egtedar's license to practice medicine in the state of Nevada pursuant to Nevada Revised
18 Statute (NRS) 630.326(1), based upon the following preliminary findings:

- 19 1. Dr. Egtedar is a physician licensed to practice medicine in the state of Nevada
20 (License No. 3055). He was originally licensed by the Board on December 3, 1975.
- 21 2. On October 30, 2015, Dr. Egtedar underwent a neuropsychological assessment
22 performed by Sharon Jones-Forrester, Ph.D.
- 23 3. A true and correct copy of the assessment was provided to the IC for its review.
- 24 4. Upon review of the conclusions and recommendations of Dr. Jones-Forrester, the
25 IC reasonably determines and believes that the health, safety and welfare of the public is at
26 imminent risk and that a summary suspension of Dr. Egtedar's license to practice medicine in the
27 state of Nevada is necessary to remove the risk of imminent harm to the health, safety and welfare
28 of the public.

Accordingly, pursuant to NRS 630.326(1):

IT IS HEREBY ORDERED that the license to practice medicine in the state of Nevada of Dr. Egtedar (License No. 3055) is **HEREBY SUSPENDED** until further order of the IC or Board; and

IT IS FURTHER ORDERED that pursuant to NRS 630.326(2), a hearing on this matter is set for December 29, 2015, at 10:00 a.m. at the Board's office located at 1105 Terminal Way, Ste. 301, Reno, NV 89502, to determine whether this suspension may continue, unless the parties mutually agree in writing to a divergent time frame.
