

10 **ORDER TERMINATING PROBATION**
11 **ON LICENSE TO PRACTICE MEDICINE**

12 Douglas Stewart Lynch, PA-C (Mr. Lynch), License No. PA1486, personally appeared in
13 Las Vegas, Nevada, before the Nevada State Board of Medical Examiners (Board) at its regularly
14 scheduled meeting on December 1, 2017, requesting termination of the probationary status of his
15 license to practice medicine in the State of Nevada. After considering the request and speaking
16 with Mr. Lynch, and considering his ongoing compliance with the terms of his Settlement
17 Agreement dated September 11, 2015, and good cause appearing, the Board enters the following
18 order:

19 **IT IS HEREBY ORDERED** that the probationary status on Mr. Lynch's license to
20 practice medicine in the State of Nevada is terminated and his license is restored to an active
21 status, with the condition that Mr. Lynch shall remain bound by the terms of the Settlement
22 Agreement until they expire or until further order of the Board.


