14 **ORDER OF SUMMARY SUSPENSION & NOTICE OF HEARING**

15 The Investigative Committee¹ (IC) of the Nevada State Board of Medical Examiners (Board)
16 hereby **IMMEDIATELY SUMMARILY SUSPENDS** the license of Corey Bueno, CRT,
17 (Respondent), from the practice of medicine, pursuant to the Board's authority to regulate the
18 practice of medicine in Nevada pursuant to Nevada Revised Statute Chapter 630 (NRS).

19 The IC issues this Order of Summary Suspension (Order) based on its determination that
20 Respondent's acts put the health, safety or welfare of the public at risk of imminent harm pursuant
21 to NRS 630.326(1).

22 Prior to the preparation of this Order, Board staff presented to the IC the following:

23 1. Respondent is a certified respiratory therapist to practice medicine in State of Nevada
24 (License RC1776).

25 2. On July 24, 2016, Respondent was arrested in Nevada for DUI (under a controlled
26 substance).

27 3. On January 25, 2017, and on February 16, 2017, Respondent was served an "Order for
28 Substance Abuse Examination," and thereby ordered pursuant to NAC 630.550 to appear for an
 examination at Montevista Hospital, located at 6000 West Rochelle, Suite 1300, Las Vegas, NV

1 89103, on March 1, 2017 at 10:00 a.m.

2 4. To date, Respondent has not complied with the aforementioned order.

3 Based on the foregoing, the IC finds that the health, safety and welfare of the public is at
4 imminent risk of harm if Respondent is permitted to continue practicing, and that an immediate
5 summary suspension of Respondent's license in the state of Nevada is necessary for the protection
6 of the public. NRS 630.326(1).

7 **ORDER**

8 **IT IS HEREBY ORDERED** that the License to practice medicine in the State of Nevada for
9 Corey D. Bueno, CRT, RC1776, is **SUMMARILY SUSPENDED** until further order of the IC or
10 Board, and Respondent is prohibited from engaging in any acts that constitute the practice of medicine;
11 and,

12 **IT IS FURTHER ORDERED** that a hearing on this matter is set for the **12th day of**
13 **October 2017 at 9:30 a.m.** at the Board's office located at 1105 Terminal Way, Ste. 301, Reno,
14 NV 89502, to determine whether this suspension may continue, unless the parties mutually agree
15 in writing to a different time. NRS 630.326(2).
