COMPLAINT

The Investigative Committee¹ (IC) of the Nevada State Board of Medical Examiners (Board) hereby issues this formal Complaint (Complaint) against Georges Youssef Tannoury, M.D. (Respondent), a physician licensed in Nevada. After investigating this matter, the IC has a reasonable basis to believe that Respondent has violated provisions of Nevada Revised Statutes (NRS) Chapter 630 and Nevada Administrative Code (NAC) Chapter 630 (collectively, the Medical Practice Act). The IC alleges the following facts:

Respondent is a physician licensed to practice medicine in the State of Nevada
 (License No. 8820). He has been continuously licensed by the Board since October 15, 1998.

A. Respondent's Treatment of Patient A

Respondent was a close acquaintance of Patient A. Patient A's true identity is not
 disclosed herein to protect his or her privacy, but is disclosed in the Patient Designation served
 upon Respondent along with a copy of this Complaint.

3. From February 2000 to September 2011, Respondent prescribed controlled
substances to Patient A, including opioids and appetite suppressants.

3	4. All of the allegations in the above paragraphs are hereby incorporated by reference

5	5. Respondent treated Patient A for chronic pain with opioid analgesics.
6	6. Violation of a standard of practice adopted by the Board is grounds for disciplinary
7	action pursuant to NRS 630.306(1)(b)(2).
8	7. The Board adopted by reference the <i>Model Policy on the Use of Opioid Analgesics</i>
9	in the Treatment of Chronic Pain, July 2013, published by the Federation of State Medical Boards
10	of the United States, Inc. (Model Policy).
11	8. Pursuant to NAC 630.230(1)(k), a licensee shall not engage in the practice of
12	writing prescriptions for controlled substances to treat acute pain or chronic pain in a manner that
13	deviates from the policies set forth in the Model Policy on the Use of Opioid Analgesics in the
14	Treatment of Chronic Pain adopted by reference in NAC 630.187.
15	9. On information and belief, Respondent wrote prescriptions to Patient A for opioid
16	analgesics to treat chronic pain in a manner that deviated from the Model Policy.
17	10. By reason of the foregoing, Respondent is subject to discipline by the Board as
18	provided in NRS 630.352.
19	<u>COUNT II</u>
20	NRS 630.306(1)(b)(2) (Violation of Standards of Practice)
21	11. All of the allegations in the above paragraphs are hereby incorporated by reference
22	as though fully set forth herein.
23	12. Violation of a standard of practice adopted by the Board is grounds for disciplinary
24	action pursuant to NRS 630.306(1)(b)(2).
25	13. The Board adopted by reference the Dietary Guidelines for Americans, 2010, 7th
26	edition, published jointly by the United States Department of Health and Human Services and the
27	Department of Agriculture pursuant to 7 U.S.C. § 5341 (Dietary Guidelines).

114.NAC 630.205 sets forth the professional standards for the prescription of appetite2suppressants, which specifially incorporates the Dietary Guidelines.

15. Respondent wrote prescriptions to Patient A for appetite suppresants in a manner that deviated from the professional standards for the prescription of appetite suppressants and the Dietary Guidelines.

16. By reason of the foregoing, Respondent is subject to discipline by the Board as provided in NRS 630.352.

Count III

NRS 630.3062(1)(a) (Failure to Maintain Complete Medical Records)

17. All of the allegations contained in the above paragraphs are hereby incorporated by reference as though fully set forth herein.

18. NRS 630.3062(1)(a) provides that the failure to maintain timely, legible, accurate and complete medical records relating to the diagnosis, treatment and care of a patient is grounds for initiating discipline against a licensee.

15 19. Respondent failed to maintain complete medical records relating to the diagnosis,
16 treatment and care of Patient A.

17 20. By reason of the foregoing, Respondent is subject to discipline by the Board as
18 provided in NRS 630.352.

WHEREFORE, the Investigative Committee prays:

1. That the Board give Respondent notice of the charges herein and give notice that
an answer to the Complaint herein may be filed as set forth in NRS 630.339(2) within twenty (20)
days of service of the Complaint;
