9 COMPLAINT

10 The Investigative Committee (IC) of the Nevada State Board of Medical Examiners (Board)
11 hereby issues this formal Complaint (Complaint) against Harish S. Hosalkar, M.D. (Respondent), a
12 licensed physician in Nevada. After investigating this matter, the IC¹ has a reasonable basis to
13 believe that Respondent has violated provisions of Nevada Revised Statutes (NRS) Chapter 630 and
14 Nevada Administrative Code (NAC) Chapter 630 (collectively, the Medical Practice Act). The IC
15 alleges the following facts:

16 1. Respondent was at all times relevant to this Complaint a physician holding an
17 active license to practice medicine in the State of Nevada. His license was originally issued on
18 March 5, 2014, and is currently licensed in active status (License No. 15200).

19 2. On November 16, 2018, the California Medical Board issued a Stipulated
20 Settlement and Disciplinary Order (Order). This Order disciplined Respondent with a stayed
21 revocation of his California license to practice medicine and placed him on probation for three (3)
22 years. Additionally, the Order stated that Respondent would take educational courses for each
23 year of his probation, and these courses shall include, but not be limited to, research protocols,
24 principle investigators' roles and responsibilities, the Institutional Review Board's (IRB) protocols
25 and processes and ethics in research.

1 within twenty (20) days of service of the Complaint;

2 2. That the Board set a time and place for a formal hearing after holding an Early
3 Case Conference pursuant to NRS 630.339(3);


4 3. That the Board determine what sanctions to impose if it finds and concludes that
5 there has been a violation or violations of the Medical Practice Act committed by Respondent;

6 4. That the Board make, issue and serve on Respondent its findings of fact,
7 conclusions of law and order, in writing, to include sanctions to be imposed; and

8 5. That the Board take such other and further action as may be just and proper in these
9 premises.
