## ORDER OF SUSPENSION AND NOTICE OF HEARING

The Investigative Committee<sup>1</sup> (IC) of the Nevada State Board of Medical Examiners (Board) hereby **IMMEDIATELY SUSPENDS** the license of James Bennett Gabroy, M.D. (Respondent) from the practice of medicine, pursuant to the Board's authority to regulate the practice of medicine in the State of Nevada pursuant to Nevada Revised Statutes (NRS) Chapter 630.

The IC issues this Order of Suspension (Order) based on its determination that Respondent violated a Board Order when he did not satisfy all of the conditions contained in the Board's Settlement Agreement and Order approved and filed by the Board on March 3, 2023, in Case No. 15-10986-1.

Prior to the preparation of this Order, Board Staff presented to the IC the following:

- 1. Respondent is a medical doctor licensed to practice medicine in the State of Nevada (License No. 7601). Respondent was originally licensed by the Board on October 30, 1995.
- 2. Pursuant to the terms of the Settlement Agreement and Order, Respondent agreed to make twelve (12) monthly payments to the Board for the fines and costs included in the Settlement Agreement starting on April 1, 2023. Respondent made five (5) payments and has not made a payment since August 1, 2023.

3.	Board staff reached	out to Respondent	regarding his	failure to	comply	with the
Settlement Ag	greement and Order.					

- 4. Respondent indicated that he was unemployed and living on social security income. Respondent further indicated that he was trying to obtain employment and that he may declare bankruptcy.
- 5. Board staff told Respondent that he was not in compliance with the Settlement Agreement and Order, and he could submit a request in writing asking the Board to modify the Settlement Agreement and Order.
- 6. Respondent has not submitted such a request, Respondent has not communicated further with Board staff, and, as of the date of this Order, Respondent has missed four (4) payments to the Board required by the Settlement Agreement and Order.
- 7. Based on the foregoing, the IC finds that Respondent has willfully and knowingly violated a Board Order and is immediately suspended from the practice of medicine in the State of Nevada. See NRS 630.326(1).

## <u>ORDER</u>

IT IS HEREBY ORDERED that the License of James Bennett Gabroy, M.D. (7601) is SUMMARILY SUSPENDED until further order of the IC or Board, and Respondent is prohibited from engaging in any acts that constitute the practice of medicine pursuant to NRS 630.020; and

IT IS FURTHER ORDERED that a hearing on this matter is set for January 22, 2023, at 1:00 p.m., at the Board's office located at 9600 Gateway Drive, Reno, Nevada 89521, to determine whether this suspension may continue, unless the parties mutually agree in writing to a different date and/or time. See NRS 630.326(2).
