Perfusionist Advisory Committee

NRS 630.2696 Temporary licenses.

- 1. The Board may issue a temporary license to practice perfusion in this State to a person who has not yet completed the examination required pursuant to NRS 630.2692 but who:
 - (a) Has completed an approved perfusion education program;
 - (b) Files an application; and
 - (c) Pays the required fee.
- 2. A perfusionist shall supervise and direct a temporarily licensed perfusionist at all times during which the temporarily licensed perfusionist performs perfusion.
- 3. A temporary license is valid for 1 year after the date it is issued and may be extended subject to regulation by the Board. The application for renewal must be signed by a supervising licensed perfusionist.
- 4. If a temporarily licensed perfusionist fails any portion of the examination required pursuant to NRS 630.2692, he or she shall immediately surrender the temporary license to the Board.

Report from Washoe County Medical Society November 9, 2023

1) New Strategic Priorities were set by the Board this summer.

Strategic Priority #1: Increase member engagement

Strategic Priority #2: Redirect finances so the majority of resources are allocated to member programs and projects to advance the mission of the Society. (This involves reducing operational expenses.)

Strategic Priority #3: Work to improve the health equity of patients in Washoe County

2) Projects

In support of Strategic Priority #3, WCMS has enrolled the Board with "Vot-ER" a program that sets up a physician with a badge so they can help patients register to vote. A voter registration card is sufficient ID for accessing services. A number of patients, including elderly who no longer drive, found ID to be a barrier. WCMS is now encouraging members to sign up for Vot-ER.

Also in support of Strategic Priority #3 (health equity) and in an effort to help address maternal mortality and morbidity, WCMS is going to host a "Community Baby Shower" in the spring. Under-served and at-risk pregnant women will be invited to attend the event, which will include lunch and an educational session. It will be possible for guests to sign up for screenings and prenatal care appointments. Guests will receive gifts, including diapers, wipes and a Pack-and-play.

3) Events

In January, WCMS will host an Inaugural event to "pass the gavel" to the new President and to recognize members for contributions to the Society and community. WCMS will continue to host their June event, which will be celebratory with focus on award recipients. It will be held at the Art Museum again in 2024.
