COMPLAINT

The Investigative Committee of the Board of Medical Examiners of the state of Nevada, composed of Charles Held, M.D., Chairman, Cindy Lamerson, M.D., Member, and Jean Stoess, M.A., Member, by and through Lyn E. Beggs, Deputy General Counsel for the Nevada State Board of Medical Examiners, having a reasonable basis to believe that Adelaida Resuello, M.D., hereinafter referred to as "Respondent," has violated the provisions of NRS Chapter 630, hereby issues its formal Complaint, stating the Investigative Committee's charges and allegations, as follows:

- 1. Respondent is licensed in active status to practice medicine in the state of Nevada, and at all times alleged herein, was so licensed by the Nevada State Board of Medical Examiners, pursuant to the provisions of Chapter 630 of the Nevada Revised Statutes.
- 2. Respondent was granted a license to practice medicine by the state of New York in January 1994.
- 3. A formal disciplinary complaint was filed against Respondent by the Nevada State Board of Medical Examiners on October 30, 2006.
- 4. The disciplinary matter was resolved by a Settlement Waiver and Consent Agreement which was accepted by the Nevada State Board of Medical Examiners on March 16, 2007, and an order was issued finding that Respondent had violated provisions of the Medical Practice Act (NRS Chapter 630) and placing Respondent on probation.
