25	July 2008, when he inserted a chest tube into a patient's right hemithorax when it was needed or

4	5. Nevada Revised Status Section 630.301(3) provides that any disciplinary action			
5	taken by another state is grounds for initiation of disciplinary action against a licensee.			
6	6. The disciplinary action taken against Dr. Okoh by the Florida Department of Health			
7	constitutes a violation of NRS 630.301(3) and accordingly Dr. Okoh is subject to discipline by the			
8	Nevada State Board of Medical Examiners as provided in Section 630.352 of the Nevada Revised			
9	Statutes.			
10	WHEREFORE, the Investigative Committee prays:			
11	1. That the Nevada State Board of Medical Examiners fix a time and place for a			
12 formal hearing;				
13	2. That the Nevada State Board of Medical Examiners give Dr. Okoh notice of the
