COMPLAINT

The Investigative Committee of the Nevada State Board of Medical Examiners, composed of Sohail U. Anjum, M.D., Chairman, S. Daniel McBride, Member, and Van Heffner, Member, by and through Lyn E. Beggs, General Counsel for the Nevada State Board of Medical Examiners, having a reasonable basis to believe that Troy Eden, P.A.-C., hereinafter referred to as Mr. Eden, has violated the provisions of NRS Chapter 630, hereby issues its formal Complaint, stating the Investigative Committee's charges and allegations, as follows:

1. Mr. Eden is currently licensed in active status, and was so licensed by the Nevada State Board of Medical Examiners, hereinafter referred to as "the Board," on November 27, 2006 (License No. PA1026), pursuant to the provisions of Chapter 630 of the Nevada Revised Statutes, and at all times addressed herein was so licensed.

2. In October 2008, it was discovered that Mr. Eden had been signing multiple blank prescriptions, in a page format, after a page containing signed blank prescriptions was faxed by his office to a local pharmacy in Elko, Nevada.

3. Mr. Eden admitted that "multi Rx" forms were commonly being used in his office and faxed to pharmacies for the expediting of refilling non-controlled substance prescriptions.

Count I

4. Nevada Administrative Code Section 630.380(1)(m) provides that violation of a provision of NRS 630.301 to 630.3065 is ground for initiating a disciplinary action against a physician assistant.

5. Nevada Revised Statute Section 630.304(4) prohibits the signing of a blank prescription form.

6. Mr. Eden violated Nevada Revised Statute Section 630.304(4) when he signed sheets of multiple prescription forms which were left blank.

7. By reason of the foregoing, Mr. Miller is subject to discipline by the Nevada State Board of Medical Examiners as provided in Section 630.410 of the Nevada Administrative Code.

**WHEREFORE**, the Investigative Committee prays:

1. That the Nevada State Board of Medical Examiners fix a time and place for a formal hearing;

2. That the Nevada State Board of Medical Examiners give Mr. Miller notice of the charges herein against him, the time and place set for the hearing, and the possible sanctions against him;

3. That the Nevada State Board of Medical Examiners determine what sanctions it determines to impose for the violation or violations committed by Mr. Miller; and

4. That the Nevada State Board of Medical Examiners make, issue and serve on Mr. Miller its findings of facts, conclusions of law and order, in writing, that includes the sanctions imposed; and

5. That the Nevada State Board of Medical Examiners take such other and further action as may be just and proper in these premises.
