10 **COMPLAINT**

11 The Investigative Committee of the Nevada State Board of Medical Examiners, composed
12 at the time filing of Charles N. Held, M.D., Chairman, Theodore B. Berndt, M.D., Member, and
13 Valerie J. Clark, Member, by and through Bradley O. Van Ry, Deputy General Counsel, having a
14 reasonable basis to believe that Michael Rosenman, M.D., hereinafter referred to as "Respondent",
15 has violated the provisions of NRS Chapter 630, hereby issues its formal Complaint, stating the
16 Investigative Committee's charges and allegations, as follows:
17

18 1. Respondent is currently licensed in active status (License No. 7991), and has been
19 so licensed since September 26, 1996 by the Nevada State Board of Medical Examiners pursuant
20 to the provisions of Chapter 630 of the Nevada Revised Statutes.

21 2. Respondent's authorized billing network contract with CIGNA Healthcare
22 hereinafter ("CIGNA") was terminated in January, 2003. As a result, he was not authorized to bill
23 CIGNA for medical services after that date.

24 3. Beginning on or about August 20, 2003 and continuing through
25 December 31, 2004, Respondent performed medical services and billed CIGNA for medical
26 services although not authorized to do so. He did this by using his partner's, and ex-wife's name,
27 Dr. Miroslava Mogler hereinafter referred to as "Dr. Mogler", and billing authorization number
28 with CIGNA to submit the bills to CIGNA. Thus, on multiple instances and over the course of


3. That the Nevada State Board of Medical Examiners determine what sanctions it decides to impose for the violation or violations committed by Respondent; and

5. That the Nevada State Board of Medical Examiners take such other and further action as may be just and proper in these premises.




