

10 **SETTLEMENT, WAIVER AND CONSENT AGREEMENT**

11 **THIS AGREEMENT** is entered into by and between the Investigative Committee (IC) of
12 the Nevada State Board of Medical Examiners (the Board) composed of
13 Charles N. Held, M.D, Theodore B. Berndt, M.D. and Ms. Valerie Clark, BSN, RHU, LUTCF, by
14 and through counsel, Lyn E. Beggs, Esq., and Thomas Sazani, M.D. (Respondent), by and through
15 ^{his} ~~her~~ counsel Kata Kim, Esq., as follows: 

16 **WHEREAS**, on August 6, 2010, the Board's IC filed a Complaint in the above referenced
17 matter charging Respondent with engaging in conduct that is grounds for discipline pursuant to the
18 Medical Practice Act (NRS Chapter 630 and NAC Chapter 630) to wit: one count of disciplinary
19 action having been taken on a license to practice medicine by another state, a violation of
20 NRS 630.301(3); and

21 **WHEREAS**, Respondent has received and reviewed a copy of the Complaint, understands
22 the nature and significance of the Complaint and has consulted with competent counsel Kata Kim
23 Esq., concerning his rights and defenses to the Complaint as well as the possible sanctions that
24 may be imposed if the Board finds and concludes that he has engaged in conduct that is grounds
25 for discipline pursuant to the Medical Practice Act and after due consideration concedes that he
26 was disciplined by the Medical Board of California as set forth in count I of the Complaint; and

1 **WHEREAS**, Respondent understands and agrees that this Agreement is entered into by
2 and between himself and the Board's Investigative Committee, and not with the Board, but that the
3 Investigative Committee will present this Agreement to the Board for consideration in open
4 session at a Board meeting, appropriately noticed, and that the Investigative Committee shall
5 advocate approval of this Agreement by the Board, but that the Board has the right to decide in its
6 own discretion whether or not to approve this Agreement; and

7 **WHEREAS**, Respondent and the Investigative Committee each understand and agree that
8 if the Board approves the terms, covenants and conditions of this Agreement, then the terms,
9 covenants and conditions enumerated below shall be binding and enforceable upon Respondent
10 and the Board's Investigative Committee; and

11 **NOW THEREFORE**, in order to resolve the above-captioned case and charges brought
12 against Respondent by the Board's Investigative Committee in said matter, Respondent and the
13 Investigative Committee hereby agree to the following terms, covenants and conditions:

14 1. **Consent to Entry of Order.** In order to resolve the matter of these disciplinary
15 proceedings pending against him without any further costs and expense of providing a defense to
16 the Complaint or to any amended complaints, Respondent hereby agrees that an order may be
17 entered herein by the Board finding that Respondent engaged in conduct that is grounds for
18 discipline pursuant to the Medical Practice Act to wit: one count of disciplinary action having been
19 taken on a license to practice medicine by another as set forth in count I of the Complaint, a
20 violation of NRS 630.301(3); and ordering that Respondent be issued a public reprimand and shall
21 pay a fine of \$1,500. Furthermore, Respondent shall be ordered to reimburse the Board the
22 reasonable costs and expenses incurred in the investigation and prosecution of this case, the current
23 amount being \$483.75, not including the costs necessary to effectuate the adoption and acceptance
24 of this Agreement. The costs and fine shall be paid to the Nevada State Board of Medical
25 Examiners within sixty (60) days of the acceptance of this Agreement by the Board;

26 2. **Jurisdiction.** Respondent was at all times mentioned in the Complaint filed in the
27 above-captioned matter was, a physician licensed to practice medicine in the state of Nevada

1 subject to the jurisdiction of the Board to hear and adjudicate charges of violations of the
2 Medical Practice Act (NRS 630), and to impose sanctions as provided by the Act.

3 3. **Waiver of Rights.** Respondent covenants and agrees that he enters into this
4 Agreement knowingly, willingly, and intelligently. In connection with this Agreement, and the
5 terms, covenants and conditions contained herein, Respondent knowingly, willingly, intelligently
6 and with the advice of the above named counsel, waives all rights arising under or pursuant to the
7 United States Constitution, the Constitution of the state of Nevada, NRS Chapter 630 and NRS
8 Chapter 233B that may be available to Respondent or that may apply to Respondent in connection
9 with the proceeding regarding the Complaint filed herein, the defense of said Complaint and the
10 adjudication of the charges in said Complaint, and Respondent further agrees that the matter of the
11 disciplinary action commenced by the filing of the complaint herein may be settled and resolved in
12 accordance with this Agreement without a hearing or any further proceeding, and without the right
13 to judicial review. In the event this Agreement is not approved by the Board, this Agreement shall
14 have no force and effect and Respondent shall have all rights arising under or pursuant to the
15 United States Constitution, the Constitution of the State of Nevada, NRS Chapter 630 and NRS
16 Chapter 233B that may be available to Respondent or that may apply to Respondent in connection
17 with the proceeding on the complaint filed herein.

18 4. **Acknowledgement of Reasonable Basis to Proceed.** Respondent covenants and
19 agrees that the Board's Investigative Committee has a reasonable basis to believe that Respondent
20 violated one or more provisions of the Medical Practice Act.

21 5. **Procedure for Adoption of Agreement.** It is expressly understood that this
22 Agreement will only become effective if the Board approves the recommendation of the
23 Investigative Committee for acceptance. The Investigative Committee and counsel for the
24 Investigative Committee shall recommend approval of the terms, covenants and conditions
25 contained herein by the Board in resolution of the disciplinary proceedings pending herein
26 against Respondent pursuant to the Complaint. In the course of seeking Board approval of this
27 Agreement, counsel for the Investigative Committee may communicate directly with the Board
28 staff and members of the panel of the Board who would adjudicate this case if it were to go to

1 hearing. Respondent covenants and agrees that such contacts and communication may be made
2 or conducted ex parte, without notice or opportunity to be heard on his part or on the part of his
3 counsel, if any, until the public Board meeting where this Agreement is discussed, and that such
4 contacts and communications may include, but not be limited to, matters concerning this
5 Agreement, the Complaint and the allegations therein, any and all evidence that may exist in
6 support of the Complaint, and any and all information of every nature whatsoever related to the
7 complaint against Respondent. The Investigative Committee and its counsel agree that
8 Respondent and his counsel, if any, may appear at the Board meeting where this Agreement is
9 discussed in order to respond to any and all questions that may be addressed to the Investigative
10 Committee or its counsel at such meeting.

11 6. **Effect of Acceptance of Agreement by Board.** In the event the Board approves
12 the terms, covenants and conditions set out in this Agreement, counsel for the Investigative
13 Committee will cause to be entered herein the Board's Order approving this Settlement, Waiver
14 and Consent Agreement, ordering full compliance with the terms herein and ordering that this
15 case be closed, subject to the provisions in Paragraph 1.

16 7. **Effect of Rejection of Agreement by Board.** In the event the Board does not
17 approve the terms, covenants and conditions set out in this Agreement, this Agreement shall be
18 null, void, and of no further force and effect except as to the following covenant and agreement
19 regarding disqualification of adjudicating Board panel members. Respondent agrees that,
20 notwithstanding rejection of this Agreement by the Board, nothing contained herein and nothing
21 that occurs pursuant to efforts of the Investigative Committee or its counsel to seek acceptance
22 and adoption of this Agreement by the Board shall disqualify any member of the adjudicating
23 panel of the Board from considering the charges against Respondent and participating in the
24 disciplinary proceedings in any role, including adjudication of the case, and Respondent further
25 agrees that he shall not seek to disqualify any such member absent evidence of bad faith.

26 8. **Release From Liability.** In execution of this Agreement, the Respondent, for
27 himself, his executors, successors and assigns, hereby releases and forever discharges the state
28 of Nevada, the Board, the Nevada Attorney General, and each of their members, agents and

1 employees in their representative capacities, and in their individual capacities absent evidence of
2 bad faith, from any and all manner of actions, causes of action, suits, debts, judgments,
3 executions, claims and demands whatsoever, known and unknown, in law or equity, that
4 Respondent ever had, now has, may have or claim to have, against any or all of the persons or
5 entities named in this paragraph arising out of or by reason of this investigation, this disciplinary
6 action, this settlement or its administration, in connection with the complaint. The Investigative
7 Committee hereby agrees to accept this Agreement in full settlement of all claims related to the
8 complaint, with the understanding that the final decision rests with the Board.

9 9. **Binding Effect.** Respondent covenants and agrees that this Agreement is a
10 binding and enforceable contract upon Respondent and the Board's Investigative Committee,
11 which contract may be enforced in a court or tribunal having jurisdiction.

12 10. **Forum Selection Clause.** Respondent covenants and agrees that in the event
13 either party is required to seek enforcement of this Agreement in the district court, he consents
14 to such jurisdiction, and covenants and agrees that exclusive jurisdiction shall be in the Second
15 Judicial District Court of the State of Nevada in and for the County of Washoe.

16 11. **Attorneys' Fees and Costs.** Respondent covenants and agrees that in the event
17 an action is commenced in the district court to enforce any provision of this Agreement, the
18 prevailing party shall be entitled to recover reasonable costs and attorneys' fees.

19 12. **Failure to comply with terms.** In the event the Board enters its Order approving
20 this Agreement, upon receipt of credible information that Respondent has failed to comply with
21 any term or condition of this Order, the Board shall be authorized to immediately suspend
22 Respondent's license until Respondent complies with the term or condition. Failure to comply
23 with the terms recited herein may result in additional disciplinary action being initiated against
24 Respondent for a violation of an Order of the Board in accordance with NRS 630.3065(2)(a).
