COMPLAINT

The Investigative Committee of the Nevada State Board of Medical Examiners, composed at the time filing of Charles N. Held, M.D., Chairman, Theodore B. Berndt, M.D., Member, and Valerie J. Clark, BSN, RHU, LUTCF, Member, having a reasonable basis to believe that Allan Jeffrey Stahl, M.D., hereinafter referred to as Respondent, has violated the provisions of NRS Chapter 630, hereby issues its formal Complaint, stating the Investigative Committee's charges and allegations, as follows:

1. Respondent's license is currently listed as active status (License No. 6419), and has been so licensed since March 21, 1992 by the Nevada State Board of Medical Examiners pursuant to the provisions of Chapter 630 of the Nevada Revised Statutes.

2. Patient A was a seventy-eight year old (78) male at the time of the incidents in question. His true identity is not disclosed to protect his privacy, but his identity is disclosed in the Patient Designation served on Respondent along with a copy of this Complaint.

3. On February 22, 2010, Patient A presented to Summerlin Hospital for elective placement of a permanent pacemaker by Respondent. As Respondent began to insert the pacemaker, complications arose.

4. Respondent inadvertently placed the left ventricle. Respondent further failed to recognize the incorrect placement.

1 13. By reason of the foregoing, Respondent is subject to discipline by the Nevada State
2 Board of Medical Examiners as provided in Section 630.352 of the Nevada Revised Statutes.

3 **WHEREFORE**, the Investigative Committee prays:

4 1. That the Nevada State Board of Medical Examiners give Respondent notice of the
5 charges herein against him and give him notice that he may file an answer to the Complaint herein
6 as set forth in Section 630.339 of the Nevada Revised Statutes within twenty (20) days of service of
7 the Complaint;

8 2. That the Nevada State Board of Medical Examiners set a time and place for a formal
9 hearing after holding an Early Case Conference pursuant to NRS 630.339(3);

10 3. That the Nevada State Board of Medical Examiners determine what sanctions it
11 determines to impose if it determines there has been a violation or violations of the Medical Practice
12 Act (Nevada Revised Statutes Chapter 630) committed by Respondent;

13 4. That the Nevada State Board of Medical Examiners make, issue and serve on
14 Respondent its findings of facts, conclusions of law and order, in writing, that includes the sanctions
15 imposed; and

16 5. That the Nevada State Board of Medical Examiners take such other and further action
17 as may be just and proper in these premises.


