10 **ORDER**

11 The above-entitled matter came before the Nevada State Board of Medical  
12 Examiners, hereinafter "Board," on Friday, March 11, 2011, at the Board's offices  
13 located at 1105 Terminal Way, Suite 301, Reno, Nevada, 89502, for a hearing on the  
14 Order to Show Cause filed on February 4, 2011, against Marilyn Atkins, R.R.T.,  
15 hereinafter referred to as "Respondent." The record reflects that Respondent was  
16 properly served with notice of the hearing in this matter but did not appear in either Reno  
17 or Las Vegas or have a representative present on her behalf.

18 The members of the Board participating in the decision were:  
19 Javid Anwar, M.D., Beverly Neyland, M.D., Michael Fischer, M.D., Ms. Donna Ruthe  
20 and Mrs. Sue Lowden. All other remaining members of the Board, being members of the  
21 Investigative Committee that issued the Complaint in this matter and/or entered into a  
22 Settlement, Waiver and Consent Agreement with Respondent, were excused from  
23 participating and took no part in the proceedings of the Board. Keith D. Marcher, Chief  
24 Deputy Attorney General, acted as legal counsel to the Board.

25 The Board, having received and read the Motion and Order to Show Cause filed  
26 in this matter on February 4, 2011, having reviewed its attached exhibits and having  
27 heard argument from counsel for the Investigative Committee as to why the revocation  
28 of Respondent's license, which was stayed pursuant to a Settlement, Waiver and

1 Consent Agreement approved and adopted by the Board on September 10, 2010,  
2 should be lifted and the revocation imposed due to Respondent's failure to comply with  
3 the terms of the Settlement, Waiver and Consent Agreement as set forth in the Motion  
4 for Order to Show Cause, issues the following order:

5 **IT IS HEREBY ORDERED** that the stay of revocation of the license of  
6 Marilyn Atkins, R.R.T. is hereby lifted and the license to practice respiratory care of  
7 Ms. Atkins is hereby **REVOKED**.


