## ADDENDUM TO PREVIOUSLY ADOPTED SETTLEMENT AGREEMENT

This Addendum to Previously Adopted Settlement Agreement (Addendum) is entered into by and between the Investigative Committee (IC) of the Nevada State Board of Medical Examiners (Board), composed of Theodore B. Berndt, M.D., Ms. Valerie J. Clark, BSN, RHU, LUTCF, and Michael J. Fisher, M.D., at the time the Addendum was authorized, by and through Edward O. Cousineau, J.D., Deputy Executive Director for the Board and counsel for the IC, and Sean Phong-Quoc SU, M.D. (Respondent), as follows:

WHEREAS, on or about March 5, 2010, the Board adopted the terms of a previously considered Settlement Agreement to which this Addendum is incorporated therein by reference; and

WHEREAS, Respondent understands and agrees that this Addendum is entered into by and between himself and the Board's IC, and not with the Board, but that the IC will present this Addendum to the Board for consideration in open session at a regular meeting duly noticed and scheduled, and that the IC will advocate approval of this Addendum by the Board, but that the Board has the right to decide in its own discretion whether or not to approve this Addendum; and

WHEREAS, Respondent understands and agrees that if the Board approves the terms, covenants and conditions of this Addendum, then the terms, covenants and conditions enumerated below shall be binding and enforceable upon him and the newly adopted terms of the Addendum shall supersede those terms of Paragraph 5 of the Settlement Agreement previously adopted by the

Board which have not been previously accomplished, and all other terms in the previously adopted Settlement Agreement not addressed in this Addendum shall remain in full force and effect; and

WHEREAS, Respondent understands and agrees that, if the Board does not approve the terms, covenants and conditions of this Addendum, then the terms, covenants and conditions enumerated below shall not be binding and enforceable upon him, and the terms of the previously adopted Settlement Agreement will still have their full force and effect.

**NOW THEREFORE**, Respondent and the IC hereby agree to the following new terms, covenants and conditions:

Respondent's license to practice medicine in the state of Nevada shall remain revoked, with that revocation stayed and Respondent remaining on probation for a period of twenty-four (24) months after the date of filing this Addendum, and with an obligation to comply with the following terms and conditions:

- (1) Respondent shall have twenty-four (24) additional months to reimburse the Board for the amounts of the fine and costs included in the previously adopted Settlement Agreement.
- (2) The Board shall continue to have unfettered access to Respondent's medical records, and Respondent agrees that they may be inspected randomly and unannounced to him during the term of his probation, and that Respondent will be responsible for the costs involved in this ongoing administrative oversight and shall reimburse the Board for the same.
- (3) In conjunction with the constraints enunciated in the previously adopted Settlement Agreement, Respondent will be authorized to perform, delegate the performance of procedures to another who would be authorized under his authority as a licensee, and associate with another practitioner only the following non-invasive cosmetic medical procedures during the term of his probation or anytime thereafter:
  - (a) **Botox Cosmetic Treatments**
  - **Dermal Filler Injections** (b)
  - Laser Hair Removal (c)
  - (d) Intense Pulse Light Treatment
  - Skin Tightening and Cellulite Treatments, e.g., Thermage/Zerona (e)
  - (f) Laser Skin Treatment for Acne and Face Veins, e.g., Frazel/Varilit
  - Body Contouring Treatments, e.g., Endermologie/Velashape (g)
  - (h) Laser Treatment for Spider and Varicose Leg Veins
  - Low-Level Laser Treatment for Hair Loss (i)
