11 **ORDER LIFTING SUMMARY SUSPENSION**

12 An Order of Summary Suspension was entered on November 27, 2012, by the
13 Investigative Committee of the Nevada State Board of Medical Examiners, composed of
14 Theodore B. Berndt, M.D., Chairman, Valerie J. Clark, BSN, RHU, LUTCF, Member, and
15 Michael J. Fischer, M.D., Member, regarding John Blackburn Siegler, M.D. (Dr. Siegler).
16 Following the Order of Summary Suspension, Dr. Siegler fully complied with the Investigative
17 Committee and was found fit and competent to practice medicine with reasonable skill and safety
18 to his patients in the state of Nevada by a neutral and independent evaluator.

19 Furthermore, as a result of Dr. Siegler's actions subsequent to the Order of Summary
20 Suspension and relying upon the independent evaluation of Dr. Siegler, the
21 Investigative Committee has reasonably determined that Dr. Siegler is not a threat to the health,
22 safety and welfare of the public and that the public is not at imminent risk of harm. It is; therefore,
23 appropriate to lift the summary suspension of Dr. Siegler's license to practice medicine in the state
24 of Nevada with no restrictions, conditions or limitations thereto.¹
