**NOTICE IS HEREBY GIVEN** that an Order of Summary Suspension has been filed by the Investigative Committee of the Nevada State Board of Medical Examiners pursuant to Chapter 630 of the Nevada Revised Statutes charging Respondent with a violation of the Medical Practice Act. A true and

correct copy of said Order of Summary Suspension has been previously served upon Respondent and is

hereby incorporated by reference.<sup>1</sup>

NOTICE IS FURTHER HEREBY GIVEN to Respondent that an Order to Show Cause Hearing

before the Hearing Officer of the Nevada State Board of Medical Examiners on the aforesaid Order of

Summary Suspension is scheduled to commence at 10:00 a.m. on Wednesday, April 24, 2013, in the conference room of the Nevada State Board of Medical Examiners, Suite 301, 1105 Terminal Way, Reno, Nevada.

RESPONDENT IS FURTHER NOTICED that he may elect to participate in the Order to Show Cause Hearing by telephone if prior arrangements are made with the General Counsel for the Investigative Committee of the Nevada State Board of Medical Examiners in sufficient time prior to the time and date fixed to arrange that alternative means of participation.

RESPONDENT IF FINALLY HEREBY NOTICED that he has the right to appear at the Order to Show Cause Hearing in person or by legal counsel and to be heard and present evidence and witnesses on his behalf at the aforesaid time and place fixed for said proceeding regarding the Order of Summary Suspension. Respondent is further advised that based on a sustained charge of one or more of the issues raised in said Order of Summary Suspension, as authorized by NRS 630.352, one or more of the following sanctions may be imposed:

- A. The continuation of the Order of Summary Suspension for an indefinite period pending the resolution of the underlying charges by virtue of stipulation of the parties or the resolution of the allegations by further disciplinary proceedings;
- B. After further disciplinary proceedings based on the scheduling of a Pre-Hearing Conference and Hearing, the range of sanctions possible includes one or more of the following:
  - Probation for a specified period on any of the conditions specified in an order issued by the Board;
  - 2. A public reprimand;
  - Limits on Respondent's practice or exclusion of one or more specified branches of medicine from Respondent's practice;

- 4. Suspension of Respondent's medical license for a specified period or until further order of the Board;
- 5. Revocation of Respondent's license to practice medicine;
- 6. A requirement that Respondent participate in a program to correct any alcohol or drug dependency or any other impairment;
- 7. A requirement for supervision of Respondent's practice;
- 8. Imposition of a fine not to exceed \$5,000.00 for each violation;
- 9. A requirement that Respondent perform public service without compensation;
- 10. A requirement that Respondent take a physical or mental examination, or an examination testing Respondent's competency;
- 11. A requirement that Respondent fulfill any such training or educational requirements as specified in an order issued by the Board;
- 12. A requirement that the Respondent pay all costs incurred by the Board relating to this disciplinary proceeding, as more fully set forth in NRS 622.400.
