13 **ORDER EXTENDING SUMMARY SUSPENSION PENDING**  
14 **RESOLUTION OF FORMAL AND/OR FIRST AMENDED COMPLAINT**

15 The Nevada State Board of Medical Examiners (Board), by and through its Investigative  
16 Committee (IC), composed of Theodore B. Berndt, M.D., Chairman, Valerie J. Clark,  
17 BSN, RHU, LUTCF, Member, and Michael J. Fischer, M.D., Member, hereby orders the  
18 extension of the suspension of Emmanuel Galang Acosta, M.D.'s (Dr. Acosta) license to practice  
19 medicine in the state of Nevada. This Order is made and based upon Nevada Revised Statutes  
20 (NRS) 630.326, a review of the pleadings in this matter, and the hearing officer's  
21 Recommendation to the Board for Order Extending Summary Suspension Pending Further  
22 Disciplinary Proceedings, or Order of the Investigative Committee or Board (Recommendation).

23 Previously, Dr. Acosta's license was suspended by IC order on August 13, 2012. A Board  
24 hearing addressing the propriety of continuing the suspension was held before a hearing officer on  
25 April 24, 2013. The hearing officer's Recommendation was submitted to the IC thereafter. A  
26 formal Complaint alleging a violation of the Nevada Medical Practice Act, NRS Chapter 630 and  
27 Nevada Administrative Code (NAC) Chapter 630, was previously filed on August 13, 2012,  
28 Case No. 12-26709-1, and was served pursuant to NRS 630.344. A First Amended Complaint

1 shall be filed against Dr. Acosta in the immediate future and served upon him pursuant to  
2 NRS 630.344.

3 Accordingly, pursuant to NRS 630.326, and based upon the hearing officer's  
4 Recommendation, as well as all of the pleadings in this matter:

5 **IT IS HEREBY ORDERED** that Dr. Acosta's license to practice medicine in the state of  
6 Nevada, license number 10462, remain **SUSPENDED**, and that this **SUSPENSION** shall remain  
7 effective pending full resolution of the formal Complaint and/or First Amended Complaint filed  
8 against Dr. Acosta, Case No. 12-26709-1, or further order of the IC and/or Board.


