13 **SECOND ORDER OF SUMMARY SUSPENSION**

14 Prior to the preparation of this Order of Summary Suspension, Nevada State Board of
15 Medical Examiners' (Board) staff presented evidence and information to an Investigative
16 Committee (IC) of the Board, composed of Theodore B. Berndt, M.D., Chairman,
17 Valerie J. Clark, BSN, RHU, LUTCF, Member, and Michael J. Fischer, M.D., Member, regarding
18 David Lynn Packer, M.D. (Dr. Packer). Upon review of the evidence and information presented
19 by Board staff, the IC hereby **IMMEDIATELY SUSPENDS** Dr. Packer's license to practice
20 medicine in the state of Nevada pursuant to Nevada Revised Statutes (NRS) 630.326(1), based
upon the following preliminary findings:

21 1. Dr. Packer is a physician licensed to practice medicine in the state of Nevada and
22 was originally licensed on January 28, 2009. Dr. Packer practices medicine in the Las Vegas area
23 and his specialties listed with the Board are Plastic Surgery, Family Practice and Urgent Care.

24 2. Dr. Packer was served with an Order for Evaluation by the IC on April 18, 2013,
25 setting an evaluation of Dr. Packer for April 30, 2013, at 11:15 a.m., with Melissa Piasecki, M.D.,
26 at her office located at 1135 Terminal Way, Suite 106, Reno, Nevada 89502.

27 3. Dr. Packer failed to appear at the evaluation as ordered by the IC.

1 4. Pursuant to NRS 630.318(3), the failure of Dr. Packer to submit to the evaluation
2 constitutes an admission of the charges against him.

3 As a result of the foregoing, the IC reasonably determines and believes that due to
4 Dr. Packer's failure to comply with its request for an evaluation, the health, safety and welfare of
5 the public is at imminent risk of harm and that summary suspension of Dr. Packer's license to
6 practice medicine is necessary to remove said risk of imminent harm to the health, safety and
7 welfare of the public.

8 Accordingly, pursuant to NRS 630.326(1):

9 **IT IS HEREBY ORDERED** that the license to practice medicine in the state of Nevada
10 of David Lynn Packer, M.D. (License No. 13014) is **HEREBY SUSPENDED** until further order
11 of the IC or Board; and,

12 **IT IS FURTHER ORDERED** that a hearing is set for July 23, 2013 at 9:00 a.m. at the
13 Board offices in Reno, Nevada, pursuant to NRS 630.326(2), to determine whether this suspension
14 may continue, unless the parties mutually agree to a divergent time frame.
