COMPLAINT

The Investigative Committee¹ (IC) of the Nevada State Board of Medical Examiners (Board) hereby issues this formal Complaint (Complaint) against Maria Corazon Orozco Regalado, M.D. (Respondent), a licensed physician in Nevada. After investigating this matter, the IC has a reasonable basis to believe that Respondent has violated provisions of Nevada Revised Statutes (NRS) chapter 630 and Nevada Administrative Code chapter 630 (collectively, the Medical Practice Act). The IC alleges the following facts:

1. Respondent is currently licensed in active status (License No. 8966), and has been licensed by the Board since April 27, 1999, pursuant to the provisions of the Medical Practice Act.
2. In a letter to the Board dated August 11, 2014, Respondent admitted having left pre-signed prescription forms for her advanced practice registered nurses (APRNs), to use while Respondent was on emergency family leave in the Philippines from April 28, 2014, through May 23, 2014.
3. The Board may initiate disciplinary action when it finds a licensee signed a blank prescription form. NRS 630.304(4)
