ORDER OF SUMMARY SUSPENSION

On September 28, 2017, the Nevada State Board of Medical Examiners (Board) staff presented evidence and information to the Investigative Committee of Board, composed of Wayne Hardwick, M.D., Chairman, Aury Nagy, M.D., Member, and M. Neil Duxbury, Public Member, regarding Angela Lorenzo, PA-C (Licensee). Upon review of the evidence and information presented by Board staff, the Investigative Committee hereby **IMMEDIATELY SUSPENDS** the license to practice medicine of Licensee pursuant to NRS 630.326(1) based upon the following preliminary findings:

1. Pursuant to NAC 630.375(2), a physician assistant shall not perform medical services without supervision from a supervising physician licensed and approved by the Board.

2. Pursuant to NRS 630.304(1), a licensee shall not maintain a license to practice medicine by fraud or misrepresentation or by any false, misleading, inaccurate or incomplete statement.

3. Pursuant to NRS 630.3065(2)(a), a licensee shall not knowingly or willfully fail to comply with a subpoena or order of the Board.

4. On September 5, 2017, the Board was notified in writing by Licensee's previous supervising physician that such supervision terminated on July 1, 2017, and that Licensee is therefore not currently supervised by a physician licensed and approved by the Board.

5. On September 6, 2017, IC staff personally notified Licensee at her offices located at 911 N. Buffalo Drive, Suite 113, Las Vegas, NV 89128-8397, where she was actively

1 performing medical services, that she had no supervising physician, and that she was prohibited  
2 pursuant to NAC 630.375(2) from performing medical services until she obtained a supervising  
3 physician licensed and approved by the Board. At that time, the IC staff also served Licensee with  
4 a written Order to produce all records of her supervision for the previous twenty-four (24) months  
5 pertaining to the program of supervision maintained by her supervising physician.

6 6. On September 6, 2017, Respondent informed the IC verbally and in writing that  
7 she would cease practicing and comply with the IC's Order to produce records of her supervision.

8 7. On September 11, 2017, Licensee wrote a prescription to a patient for Phentermine,  
9 a Schedule IV controlled substance pursuant to NAC 453.540(5).

10 8. As of this writing, Licensee has not produced any records in response to the IC's  
11 Order of September 6, 2017.

12 9. Therefore, Licensee is performing medical services, including the prescription of  
13 controlled substances, (1) without supervision, in violation of NAC 630.375(2), and (2) in direct  
14 contradiction to her prior written statement to the Board on September 6, 2017, in violation of  
15 NRS 630.304(1). Licensee is also knowingly and willfully failing to comply with the IC's lawful  
16 Order to produce medical records, in violation of NRS 630.3065(2)(a).

17 Based thereon, the IC believes that the health, safety and welfare of the public is at  
18 imminent risk of harm by Licensee's continued performance of medical services without  
19 supervision, including the prescription of controlled substances, by her dishonest conduct, and by  
20 her continued refusal to comply with the lawful Orders of the Board. Based upon the  
21 aforementioned, the IC reasonably believes that a summary suspension of Licensee's medical  
22 license is necessary to remove said risk of imminent harm to the health, safety and welfare of the  
23 public as authorized and pursuant to NRS 630.326(1):

24 **IT IS HEREBY ORDERED** that the license to practice medicine in the state of Nevada  
25 of **ANGELA LORENZO, PA-C**, (License No. PA816) is hereby suspended until further order of  
26 the IC or Board; and

27 **IT IS FURTHER ORDERED** that pursuant to NRS 630.326(2), a hearing be set of this  
28 Order at 1:30 p.m., on Wednesday, November 29, 2017, at the Board's offices at 1105 Terminal
