Upon review of the evidence and information presented by Board staff, the IC hereby IMMEDIATELY SUSPENDS 16 Dr. Hearne's license to practice medicine in the state of Nevada pursuant to Nevada Revised 17 Statute (NRS) 630.326(1), based upon the following preliminary findings: 18 19 1. Dr. Hearne is a physician licensed to practice medicine in the state of Nevada (License No. 10767) and was originally licensed on January 7, 2004. Dr. Hearne lists his specialty 20with the Board as Ophthalmology. 21 2. On July 16, 2018, pursuant to NRS 630.311(1) the IC issued an Order For 22 23 Appearance (Order) whereby Dr. Hearne was required ("shall") appear before the IC to discuss his five (5) currently open investigations with the aforementioned IC members. 24 3. On August 8, 2018, Dr. Hearne did not appear as ordered. 25 26 4. On August 8, 2018, this IC has reasonably determined that the health, safety, or welfare of the public and any patient served by Dr. Hearne is at risk of imminent or continued 27 28

harm based upon in his failure to appear and in light of other relevant and confidential
 information.

Accordingly, pursuant to NRS 630.326(1):

4 **IT IS HEREBY ORDERED** that the license to practice medicine in the state of Nevada 5 of Isaac John Hearne, M.D. (License No. 10767) is **HEREBY SUSPENDED** until further order of 6 the Investigative Committee or the Board; and,

7 IT IS FURTHER ORDERED that pursuant to NRS 630.326(2), a hearing on this matter
8 is set for the <u>11<sup>th</sup> of October 2018, 2:00 p.m.</u>, at the Board's office located at 9600 Gateway
9 Drive, Reno, NV, 89521 to determine whether this suspension may continue, unless the parties
10 mutually agree in writing to a different date and/or time; and,

IT IS FURTHER ORDERED that pursuant to NRS 630.326(3), this IC requires Dr. Hearne to a mental and physical examination, which must be conducted and these examination results obtained and submitted to this IC not later than 30 days after this Order is issued.
