NEVADA STATE BOARD OF MEDICAL EXAMINERS

COMPLAINT

The Investigative Committee¹ (IC) of the Nevada State Board of Medical Examiners ("Board") hereby issues this formal Complaint against Michelle R. Clouthier, RRT (hereinafter referred to as Respondent), a licensed Registered Respiratory Therapist (RRT) in Nevada. After investigating this matter, the IC has a reasonable basis to believe that Respondent has violated provisions of Nevada Revised Statutes (NRS) Chapter 630 and Nevada Administrative Code (NAC) Chapter 630 (collectively, the Medical Practice Act).

The IC alleges the following facts:

- 1. Respondent is currently licensed in active status (License No. RC363). Respondent was issued her license from the Board on December 14, 2001, pursuant to the provisions of NRS Chapter 630.
- 2. Patient A was a 61-year-old female at the time of the events at issue. Her true identity is not disclosed herein to protect her privacy, but is disclosed in the Patient Designation served upon Respondent along with a copy of this Complaint.
- 3. On or about November 15, 2014, Patient A, who was in critical condition and recently intubated, was admitted to the Medical Intensive Care Unit (MICU) of Desert Springs

Hospital in Las Vegas, Nevada. Patient A was then transported from the MICU to receive a CT scan and back to the MICU on the same day.

- Cynthia V. Ivey, CRT (Ms. Ivey) was the respiratory therapist assigned to 4. accompany Patient A and provide her respiratory expertise and necessary respiratory equipment to ensure safe transport. Respondent and Ms. Ivey were coworkers and were both respiratory therapists at Desert Springs Hospital.
- Another medical provider was also assigned to accompany Patient A and provide 5. medical expertise, monitoring equipment and medications that may have been necessary to ensure a safe transport.
- Upon information and belief, during transport of Patient A back from the CT scan, 6. the supplemental oxygen supply apparently ran out and a manual resuscitation bag was not available to continue necessary ventilation.
- Following these events, Ms. Ivey failed to document this information in Patient A's 7. medical records as required by NRS 630.3062(1)(a) at the end of her shift on November 15, 2014.
- Two days later, on or about November 17, 2014, at the request and direction of Ms. 8. Ivey, Respondent made an entry into Patient A's medical records using Ms. Ivey's electronic signature (logon ID and password), which Ms. Ivey provided to Respondent.
- Ms. Ivey made that request to Respondent via text message to Respondent that 9. stated, "Pt. in MICU 10 add note for yesterday 5:30 pm that Patient desaturated on the way back from CT bagged Patient till oxygen came back up then put patient back on vent."
- Respondent did not provide or observe the patient care of Patient A, provided by 10. Ms. Ivey, on or about November 15, 2014.

COUNT I

Failure to Maintain Timely, Legible, Accurate and Complete Medical Records Patient A - NRS 630.3062(1)(a)

All of the allegations in the above paragraphs are hereby incorporated by reference 11. as though fully set forth herein.

- 12. NRS 630.3062(1)(a) provides that the failure to maintain timely, legible, accurate and complete medical records relating to the diagnosis, treatment and care of a patient constitutes grounds for initiating disciplinary action.
- 13. Respondent failed to maintain timely, legible, accurate and complete medical records/notes relating to the diagnosis, treatment, and care of Patient A when she acquiesced to Ms. Ivey's direction and request to enter Ms. Ivey's medical note two days after the event, when Respondent did not witness the treatment of Patient A by Ms. Ivey.
- 14. By reason of the foregoing, Respondent is subject to discipline by the Board as provided in NRS 630.352.

COUNT II

Misrepresentation in Obtaining or Renewing License NRS 630.304(1)

- 15. All of the allegations contained in the above paragraphs are hereby incorporated by reference as though fully set forth herein.
- 16. NRS 630.304(1) provides that obtaining, maintaining or renewing or attempting to obtain, maintain or renew a license to practice medicine by bribery, fraud or misrepresentation or by any false, misleading, inaccurate or incomplete statement constitutes grounds for initiating disciplinary action.
- 17. Desert Springs Hospital investigated Respondent as a result of the events described herein.
- Respondent failed to disclose that Desert Springs Hospital investigated the events contained herein when on Respondent's 2015 renewal application, she answered "no" to the question, "[h]ave you been: a) asked to respond to an investigation; b) notified that you were under investigation for; c) investigated for; d) charged with; e) convicted of any violation of a statute, rule or regulation governing your practice as a practitioner of respiratory care by any medical licensing board, hospital, medical society, governmental entity or agency other than the Nevada State Board of Medical Examiners?"

19. By reason of the foregoing, Respondent is subject to discipline by the Board as provided in NRS 630.352.

WHEREFORE, the Investigative Committee prays:

- 1. That the Nevada State Board of Medical Examiners give Respondent notice of the charges herein against her and give her notice that she may file an answer to the Complaint herein as set forth in NRS 630.339(2) within twenty (20) days of service of the Complaint;
- 2. That the Nevada State Board of Medical Examiners set a time and place for a formal hearing after holding an Early Case Conference pursuant to NRS 630.339(3);
- 3. That the Nevada State Board of Medical Examiners determine what sanctions to impose if it determines there has been a violation or violations of the Medical Practice Act committed by Respondent;
- 4. That the Nevada State Board of Medical Examiners make, issue and serve on Respondent its findings of fact, conclusions of law and order, in writing, that includes the sanctions imposed; and
- 5. That the Nevada State Board of Medical Examiners take such other and further action as may be just and proper in these premises.
