10 **COMPLAINT**

11 The Investigative Committee¹ (IC) of the Nevada State Board of Medical Examiners
12 (Board), by and through Robert G. Kilroy, Esq., Senior Deputy General Counsel and attorney for the
13 IC, having a reasonable basis to believe that Randi Fultz Grinsell, M.D., (Respondent) violated the
14 provisions of Nevada Revised Statutes (NRS) Chapter 630 and Nevada Administrative Code (NAC)
15 Chapter 630 (collectively, the Medical Practice Act), hereby issues its Complaint, stating the IC's
16 charges and allegations as follows:

17 1. Respondent was at all times relative to this Complaint a medical doctor holding an
18 active license to practice medicine in the State of Nevada (License No. 10448). Respondent was
19 originally licensed by the Board on April 9, 2003.

20 2. On July 2, 2015, Patient A² had her first encounter with Respondent as she was
21 transferred from another provider. Respondent obtained her prior medical history, family history,
22 and reviewed her immunization record. During the visit, Patient A denied any family history of
23 cancer. Respondent acknowledged that Patient A was scheduled for a pap smear test (PAPT) as a
24 part of her examination.
