ORDER OF SUMMARY SUSPENSION AND NOTICE OF HEARING

The Investigative Committee¹ (IC) of the Nevada State Board of Medical Examiners (Board) hereby IMMEDIATELY SUMMARILY SUSPENDS the license of Lora Leigh Watson, RRT (Licensee) from the practice of respiratory care, pursuant to the Board's authority to regulate the practice of respiratory care in the State of Nevada in accordance with Nevada Revised Statutes (NRS) Chapter 630.

The IC issues this Order of Summary Suspension based on its determination that the Licensee's acts put the health, safety or welfare of the public at risk of imminent harm pursuant to NRS 630.326(1), based upon the following preliminary findings:

Ms. Watson's is a licensed practitioner of respiratory care in the State of Nevada 18 1. (License No. RC137) and was originally licensed on November 27, 2001. 19

On November 27, 2020, Ms. Watson reported her third DUI arrest to the Board and 20 2. 21 subsequently moved to the State of Kentucky.

On September 22, 2021, the IC issued an Order for Participation in a Drug and 3. 22 Alcohol Monitoring Program and Compliance with Terms of Contract for Ms. Watson to comply 23 with a five (5) year program of counseling and random drug screens at an approved facility in 24 25 Kentucky.

On October 21, 2021, Ms. Watson entered into an agreement to participate in a 1 4. program administered by the Kentucky Professional Recovery Network (KYPRN) which is to be 2 in effect until October 21, 2026. 3

As part of the program administered by KYPRN, Ms. Watson agreed to abstain 5. from any drugs and alcohol.

On February 23, 2022, KYPRN notified the Board that Ms. Watson tested positive 6. for alcohol metabolites from a blood draw on February 10, 2022.

7. Ms. Watson believed that she had obtained a false positive and selected for a follow up blood test on or around February 24, 2022.

On March 11, 2022, KYPRN notified the Board that Ms. Watson tested positive for 8. alcohol metabolites from the February 24, 2022, blood draw.

On January 24, 2023, KYPRN notified the Board that Ms. Watson tested positive 9. for alcohol metabolites. KYPRN indicated that the draw was taken from Ms. Watson on January 12, 2023.

Ms. Watson was informed of the positive result in an email exchange between her 10. and KYPRN. Ms. Watson continues to deny any alcohol consumption.

KYPRN has informed the Board that the blood test is considered a confirmation for 11. exposure to and metabolism of beverage alcohol. 18

On February 22, 2023, the IC reasonably determined that the health, safety, or 19 12. welfare of the public and any patient served by Ms. Watson is at risk of imminent or continued 20 harm because Ms. Watson has repeatedly failed to comply with the terms of the KYPRN program 21 to abstain from consuming alcohol by testing positive for exposure to and metabolism of beverage 22 alcohol on three (3) different tests administered between February 10, 2022 and January 12, 2023. 23 Accordingly, pursuant to NRS 630.326(1): 24

IT IS HEREBY ORDERED that the license to practice respiratory care in the State of 25 Nevada of Lora Leigh Watson, RRT (License No. RC137) is HEREBY SUSPENDED until 26 further order of the Investigative Committee or the Board; and, 27
