10 **ORDER OF SUSPENSION AND NOTICE OF HEARING**

11 The Investigative Committee¹ (IC) of the Nevada State Board of Medical Examiners
12 (Board) hereby **IMMEDIATELY SUSPENDS** the license of James Bennett Gabroy, M.D.
13 (Respondent) from the practice of medicine, pursuant to the Board's authority to regulate the
14 practice of medicine in the State of Nevada pursuant to Nevada Revised Statutes (NRS)
15 Chapter 630.

16 The IC issues this Order of Suspension (Order) based on its determination that Respondent
17 violated a Board Order when he did not satisfy all of the conditions contained in the Board's
18 Settlement Agreement and Order approved and filed by the Board on March 3, 2023, in
19 Case No. 15-10986-1.

20 Prior to the preparation of this Order, Board Staff presented to the IC the following:

21 1. Respondent is a medical doctor licensed to practice medicine in the State of
22 Nevada (License No. 7601). Respondent was originally licensed by the Board on
23 October 30, 1995.

24 2. Pursuant to the terms of the Settlement Agreement and Order, Respondent agreed
25 to make twelve (12) monthly payments to the Board for the fines and costs included in the
26 Settlement Agreement starting on April 1, 2023. Respondent made five (5) payments and has not
27 made a payment since August 1, 2023.

1 3. Board staff reached out to Respondent regarding his failure to comply with the
2 Settlement Agreement and Order.

3 4. Respondent indicated that he was unemployed and living on social security
4 income. Respondent further indicated that he was trying to obtain employment and that he may
5 declare bankruptcy.

6 5. Board staff told Respondent that he was not in compliance with the Settlement
7 Agreement and Order, and he could submit a request in writing asking the Board to modify the
8 Settlement Agreement and Order.

9 6. Respondent has not submitted such a request, Respondent has not communicated
10 further with Board staff, and, as of the date of this Order, Respondent has missed four (4)
11 payments to the Board required by the Settlement Agreement and Order.

12 7. Based on the foregoing, the IC finds that Respondent has willfully and knowingly
13 violated a Board Order and is immediately suspended from the practice of medicine in the State of
14 Nevada. *See* NRS 630.326(1).

15 **ORDER**

16 **IT IS HEREBY ORDERED** that the License of James Bennett Gabroy, M.D. (7601) is
17 **SUMMARILY SUSPENDED** until further order of the IC or Board, and Respondent is
18 **prohibited** from engaging in any acts that constitute the practice of medicine pursuant to
19 NRS 630.020; and

20 **IT IS FURTHER ORDERED** that a hearing on this matter is set for **January 22, 2023,**
21 **at 1:00 p.m.,** at the Board's office located at 9600 Gateway Drive, Reno, Nevada 89521, to
22 determine whether this suspension may continue, unless the parties mutually agree in writing to a
23 different date and/or time. *See* NRS 630.326(2).
