James Bennett Gabroy, M.D. (Respondent), License No. 7601, personally appeared in Las Vegas, Nevada, before the Nevada State Board of Medical Examiners (Board) at its regularly scheduled meeting on March 1, 2024, requesting modification of the terms of the Settlement Agreement and Order in this case, filed on March 3, 2023 (March 2023 Order).

After considering the request, the Board enters the following order modifying the terms of the March 2023 Order:

17 1. The remaining balance of the fines due in Case No. 15-10986-1 in the amount of 18 two thousand nine hundred nineteen dollars (\$2,919) shall be paid in twenty-four (24) equal 19 payments of one hundred twenty-one dollars and sixty-three cents (\$121.63), with the first 20 payment due April 1, 2024, and the last payment of one hundred twenty-one dollars and fifty-one 21 cents (\$121.51) due by March 1, 2026.

22 2. The remaining balance of the fees and costs due in Case No. 15-10986-1 in the 23 amount of five thousand five hundred eighty-four dollars (\$5,584) shall be paid in twenty-four 24 (24) equal payments of two hundred thirty-two dollars and sixty-seven cents (\$232.67), with the 25 first payment due April 1, 2024, and the last payment of two hundred thirty-two dollars and fifty-26 nine cents (\$232.59) due by March 1, 2026.

27 3. Upon receipt of Respondent's April 1, 2024 payments totaling \$354.30,
28 Respondent's license shall be removed from suspended status and placed on active status.
