10 **SETTLEMENT AGREEMENT**

11 The Investigative Committee (IC) of the Nevada State Board of Medical Examiners  
12 (Board), by and through Alexander J. Hinman, Deputy General Counsel for the Board and  
13 attorney for the IC, and Gary Royce Wisner, M.D. (Respondent), a licensed physician in Nevada,  
14 assisted by his attorney, Jessica R. Gandy, Esq., of the law firm of Hutchison & Steffen, PLLC,  
15 hereby enter into this Settlement Agreement (Agreement) based on the following:<sup>1</sup>

16 **A. BACKGROUND**

17 1. Respondent is a medical doctor currently licensed in active status by the Board  
18 pursuant to Chapter 630 of the Nevada Revised Statutes (NRS) and Chapter 630 of the Nevada  
19 Administrative Code (NAC) (collectively, the Medical Practice Act) to practice medicine in  
20 Nevada. His license was originally issued on March 2, 1996 (License No. 7759).

21 2. On February 15, 2024, in Case No. 24-11112-1, the IC filed a formal Complaint  
22 (Complaint) charging Respondent with violating the Medical Practice Act. Specifically, the  
23 Complaint alleges one (1) violation of NRS 630.301(3), Disciplinary Action by Another State  
24 Medical Board (Count I). By reason of the foregoing, Respondent is subject to discipline by the  
25 Board as provided in NRS 630.352.

27 <sup>1</sup> All agreements and admissions made by Respondent are solely for final disposition of this matter and any  
28 subsequent related administrative proceedings or civil litigation involving the Board and Respondent. Therefore,  
Respondent's agreements and admissions are not intended or made for any other use, such as in the context of another  
state or federal government regulatory agency proceeding, state or federal civil or criminal proceeding, any state or  
federal court proceeding, or any credentialing or privileges matter.

1           3.     Respondent was properly served with a copy of this Complaint, has reviewed and  
2 understands this Complaint, and has had the opportunity to consult with competent counsel  
3 concerning the nature and significance of this Complaint.

4           4.     Respondent is hereby advised of his rights regarding this administrative matter, and  
5 of his opportunity to defend against the allegations in the Complaint. Specifically, Respondent has  
6 certain rights in this administrative matter as set out by the United States Constitution, the Nevada  
7 Constitution, the Medical Practice Act, the Nevada Open Meeting Law (OML), which is  
8 contained in NRS Chapter 241, and the Nevada Administrative Procedure Act (APA), which is  
9 contained in NRS Chapter 233B and 622A. These rights include the right to a formal hearing on  
10 the allegations in the Complaint, the right to representation by counsel, at his own expense, in the  
11 preparation and presentation of his defense, the right to confront and cross-examine the witnesses  
12 and evidence against him, the right to written findings of fact, conclusions of law and order  
13 reflecting the final decision of the Board, and the right to judicial review of the Board's order, if  
14 the decision is adverse to him.

15           5.     Respondent understands that, under the Board's charge to protect the public by  
16 regulating the practice of medicine, the Board may take disciplinary action against Respondent's  
17 license, including license probation, license suspension, license revocation and imposition of  
18 administrative fines, as well as any other reasonable requirement or limitation, if the Board  
19 concludes that Respondent violated one or more provisions of the Medical Practice Act.

20           6.     Respondent understands and agrees that this Agreement, by and between  
21 Respondent and the IC, is not with the Board, and that the IC will present this Agreement to the  
22 Board for consideration in open session at a duly noticed and scheduled meeting. Respondent  
23 understands that the IC shall advocate for the Board's approval of this Agreement, but that the  
24 Board has the right to decide in its own discretion whether or not to approve this Agreement.  
25 Respondent further understands and agrees that if the Board approves this Agreement, then the  
26 terms and conditions enumerated below shall be binding and enforceable upon him and the Board.

1 **B. TERMS & CONDITIONS**

2 **NOW, THEREFORE**, in order to resolve the matters addressed herein, i.e., the matters  
3 with regard to the Complaint, Respondent and the IC hereby agree to the following terms and  
4 conditions:

5 1. **Jurisdiction.** Respondent is, and at all times relevant to the Complaint has been, a  
6 physician licensed to practice medicine in Nevada subject to the jurisdiction of the Board as set  
7 forth in the Medical Practice Act.

8 2. **Representation by Counsel/Knowing, Willing and Intelligent Agreement.**  
9 Respondent acknowledges he is represented by counsel, and wishes to resolve the matters  
10 addressed herein with said counsel. Respondent agrees that if representation by counsel in this  
11 matter materially changes prior to entering into this Agreement and for the duration of this  
12 Agreement, that counsel for the IC will be timely notified of the material change. Respondent  
13 agrees that he knowingly, willingly and intelligently enters into this Agreement after deciding to  
14 have a full consultation with and upon the advice of legal counsel.

15 3. **Waiver of Rights.** In connection with this Agreement, and the associated terms  
16 and conditions, Respondent knowingly, willingly and intelligently waives all rights in connection  
17 with this administrative matter. Respondent hereby knowingly, willingly and intelligently waives  
18 all rights arising under the United States Constitution, the Nevada Constitution, the Medical  
19 Practice Act, the OML, the APA, and any other legal rights that may be available to him or that  
20 may apply to him in connection with the administrative proceedings resulting from the Complaint  
21 filed in this matter, including defense of the Complaint, adjudication of the allegations set forth in  
22 the Complaint, and imposition of any disciplinary actions or sanctions ordered by the Board.  
23 Respondent agrees to settle and resolve the allegations of the Complaint as set out by this  
24 Agreement, without a hearing or any further proceedings and without the right to judicial review.

25 4. **Acknowledgement of Reasonable Basis to Proceed.** As of the time of entering  
26 into this Settlement Agreement, the allegations of the Complaint remain unproven. Respondent  
27 acknowledges that the IC believes it has a reasonable basis to allege that Respondent engaged in  
28 conduct that is grounds for discipline pursuant to the Medical Practice Act. The IC acknowledges

1 Respondent is not admitting that the IC's claims/counts as alleged in the Complaint have merit  
2 and Respondent is agreeing to resolve this matter to avoid the costs of hearing and potential  
3 subsequent litigation. Respondent asserts if this matter were to proceed to hearing, he has  
4 evidence, witnesses, expert witness(es) and defenses to the counts/claims alleged in the  
5 Complaint, but for the purposes of resolving the matter and for no other purpose, Respondent  
6 waives the presentation of evidence, witnesses, expert witnesses, and defenses in order to  
7 effectuate this Agreement.

8 5. Consent to Entry of Order. In order to resolve this Complaint pending against  
9 Respondent, Respondent hereby agrees that the Board may issue an order finding that Respondent  
10 engaged in conduct that is grounds for discipline pursuant to the Medical Practice Act.  
11 Accordingly, the following terms and conditions are hereby agreed upon:

12 a. Respondent admits to Count I, one (1) violation of NRS 630.301(3),  
13 Disciplinary Action by Another State Medical Board.

14 b. Respondent shall pay the costs and expenses incurred in the investigation  
15 and prosecution of the above-referenced matter within sixty (60) days of the Board's acceptance,  
16 adoption, and approval of this Agreement in the amount of one thousand four hundred fifty-six  
17 dollars and seventy-eight cents (\$1,456.78).

18 c. Respondent shall pay a fine of five thousand dollars (\$5,000) in four (4)  
19 equal payments of one thousand two hundred fifty dollars (\$1,250). The first payment shall be due  
20 on or before September 5, 2024, the second payment is due on or before December 4, 2024, the  
21 third payment is due on or before March 4, 2025, and the final payment is due on or before June 2,  
22 2025. This payment plan is subject to the Board's acceptance, adoption, and approval of this  
23 Agreement."

24 d. Respondent's Medical License shall be suspended for a period of one (1)  
25 year, commencing on the date of the Board's approval of this Settlement Agreement.  
26 ("Suspension Period").

27 e. Respondent shall successfully complete a competency course approved by  
28 the Board to assess his competence and ability to practice medicine pursuant to NRS 630.352, no

1 sooner than ninety (90) days before the suspension period has expired.

2 f. Effective one (1) year from the Board's acceptance, adoption and approval  
3 of this Agreement, and contingent on compliance with the suspension provisions of this  
4 agreement, Respondent shall be on probation for a period of two (2) years ("Probation Period"),  
5 commencing at the date of the expiration of the Suspension Period.

6 g. For the duration of the Probation Period, Respondent shall have chart-  
7 monitoring from a Board approved service as follows:

8 i. Year one (1) of the Probation Period shall require 25% of patient  
9 charts to be monitored on a monthly basis, and the monitor must report monthly directly to the  
10 Board.

11 ii. Year two (2) of the Probation Period shall require 10% of patient  
12 charts to be monitored on a monthly basis, and the monitor must report monthly directly to the  
13 Board.

14 h. This Agreement shall be reported to the appropriate entities and parties as  
15 required by law, including, but not limited to, the National Practitioner Data Bank.

16 i. Respondent shall receive a Public Letter of Reprimand.

17 j. Any and all other claims arising from the Board's corresponding  
18 investigative case file(s), shall be dismissed with prejudice.

19 6. **Release from Liability.** In execution of this Agreement, Respondent understands  
20 and agrees that the State of Nevada, the Board, and each of its members, staff, counsel,  
21 investigators, experts, peer reviewers, committees, panels, hearing officers, consultants and agents  
22 are immune from civil liability for any decision or action taken in good faith in response to  
23 information acquired by the Board. NRS 630.364(2)(a). Respondent agrees to release the State of  
24 Nevada, the Board, and each of its members, staff, counsel, investigators, experts, peer reviewers,  
25 committees, panels, hearing officers, consultants and agents from any and all manner of actions,  
26 causes of action, suits, debts, judgments, executions, claims and demands whatsoever, known and  
27 unknown, in law or equity, that Respondent ever had, now has, may have or claim to have, against  
28 any or all of the persons, government agencies or entities named in this paragraph arising out of,

1 or by reason of, this investigation, this Agreement or the administration of the case referenced  
2 herein.

3 7. Procedure for Adoption of Agreement. The IC and counsel for the IC shall  
4 recommend approval and adoption of the terms and conditions of this Agreement by the Board in  
5 resolution of this Complaint. In the course of seeking Board acceptance, approval and adoption of  
6 this Agreement, counsel for the IC may communicate directly with the Board staff and the  
7 adjudicating members of the Board.

8 Respondent acknowledges that such contacts and communications may be made or  
9 conducted ex-parte, without notice or opportunity to be heard on his part until the public Board  
10 meeting where this Agreement is discussed, and that such contacts and communications may  
11 include, but may not be limited to, matters concerning this Agreement, the Complaint and any and  
12 all information of every nature whatsoever related to this matter. The IC and its counsel agree that  
13 Respondent and/or Counsel for the Respondent may appear at the Board meeting where this  
14 Agreement is discussed and, if requested, respond to any questions that may be addressed to the  
15 IC or the IC's counsel.

16 8. Effect of Acceptance of Agreement by Board. In the event the Board accepts,  
17 approves and adopts this Agreement, the Board shall issue a final order, making this Agreement  
18 an order of the Board, and, pending full compliance with the terms herein, the case shall be closed  
19 and all remaining claims arising out of the Complaint shall be dismissed with prejudice.

20 9. Effect of Rejection of Agreement by Board. In the event the Board does not  
21 accept, approve and adopt this Agreement, this Agreement shall be null, void and of no force and  
22 effect except as to the following agreement regarding adjudications: (1) Respondent agrees that,  
23 notwithstanding rejection of this Agreement by the Board, nothing contained in this Agreement  
24 and nothing that occurs pursuant to efforts of the IC to seek the Board's acceptance of this  
25 Agreement shall disqualify any member of the adjudicating panel of the Board from considering  
26 this Complaint and from participating in disciplinary proceedings against Respondent, including  
27 adjudication of this case; and (2) Respondent further agrees that he shall not seek to disqualify any  
28 such member absent evidence of bad faith.

- 1           10.    Binding Effect.  If approved by the Board, Respondent understands that this  
2 Agreement is a binding and enforceable contract upon Respondent and the Board.
- 3           11.    Forum Selection Clause.  The parties agree that in the event either party is  
4 required to seek enforcement of this Agreement in district court, the party's consent to such  
5 jurisdiction and agree that exclusive jurisdiction shall be in the Second Judicial District Court,  
6 State of Nevada, Washoe County.
- 7           12.    Attorneys' Fees and Costs.  The parties agree that in the event an action is  
8 commenced in district court to enforce any provision of this Agreement, the prevailing party shall  
9 be entitled to recover reasonable attorneys' fees and costs.
- 10          13.    Failure to Comply with Terms.  Should Respondent fail to comply with any term  
11 or condition of this Agreement once the Agreement has been accepted, approved and adopted by  
12 the Board, the IC shall be authorized to immediately suspend Respondent's license to practice  
13 medicine in Nevada pending an Order to Show Cause Hearing, which will be duly noticed.  
14 Failure to comply with the terms of this Agreement, including failure to pay any fines, costs,  
15 expenses or fees owed to the Board, is a failure to comply with an order of the Board, which may  
16 result in additional disciplinary action being taken against Respondent. NRS 630.3065(2)(a).


1 Further, Respondent's failure to remit payment to the Board for monies agreed to be paid as a


