9	ORDER OF SUMMARY SUSPENSION AND NOTICE OF HEARING
10	The Investigative Committee ¹ (IC) of the Nevada State Board of Medical Examiners
11	(Board) hereby IMMEDIATELY SUMMARILY SUSPENDS the license of Kristin Adele
12	Hestdalen, M.D. (Respondent) from the practice of medicine, pursuant to the Board's authority to
13	regulate the practice of medicine in the State of Nevada pursuant to Nevada Revised Statutes
14	(NRS) Chapter 630.
15	Prior to the preparation of this Order of Summary Suspension, Board Staff presented to the
16	IC the following:
17	1. Respondent is a medical doctor licensed to practice medicine in the State o
18	Nevada (License No. 10215). The Board issued her license on July 1, 2002.
19	2. On June 5, 2024, Respondent appeared before the Board to request a license status
20	change from inactive to active status. Respondent's license was inactive during a period when she
21	was seeking treatment for substance abuse. She was in recovery at that time and wished to re-ente
22	the practice of medicine.
23	3. Following the June 5, 2024, meeting, the Board issued an Order Granting License
24	with Conditions with the requirement that Respondent successfully complete a preceptor plan fo
25	twelve (12) months under the supervision of Dr. Byron Czerniski, a Senior Psychiatrist at Lake

Crossing ("Board Order"). She was further notified that she must return to the Board to request 1 2 that the conditions be removed from her license.

Dr. Czerniski agreed to report on Respondent's progress and notify the Board of 4. any concerning pattern in work performance, attendance, documentation, or clinical decisionmaking.

Dr. Czerniski has notified the Board of his concerns with Respondent's work 5. performance and attendance. Specifically, on January 3, 2025, Respondent was late arriving to work at Lakes Crossing and seemed to be in an altered status. Respondent entered the monthly 8 staff meeting seemingly disorganized, in addition to coworkers observing that she smelled of 9 alcohol. 10

Additionally, on the evening of January 3, 2025, Respondent texted Dr. Czerniski 6. and stated that she had relapsed in her sobriety.

7. As of January 6, 2025, Respondent no longer works at Lakes Crossing. As such, Dr. Czerniski notified the Board of the termination of the preceptorship.

Respondent's failure to complete the preceptorship under Dr. Czerniski is a 8. violation of the conditions of the Board Order.

9. Based on the foregoing, the IC finds that Respondent has willfully and knowingly 17 violated the Board Order and is immediately suspended from the practice of medicine in the State 18 19 of Nevada. See NRS 630.326(1).

Accordingly, the IC issues this Order of Summary Suspension based on its 20 10. 21 determination that Respondent's failure to comply with the Board Order puts the health, safety or welfare of the public at risk of imminent harm pursuant to NRS 630.326(1) and 22 NRS 233B.127(3). 23

ORDER

IT IS HEREBY ORDERED that the License of Kristin Adele Hestdalen, M.D. (License 25 No. 10215) is SUMMARILY SUSPENDED until further order of the IC or Board, and Licensee 26 is prohibited from engaging in any acts that constitute the practice of medicine pursuant to 27 NRS 630.020; and 28
