10                                   **COMPLAINT**

11                   The Investigative Committee<sup>1</sup> (IC) of the Nevada State Board of Medical Examiners  
12 (Board), by and through Ian J. Cumings, Senior Deputy General Counsel and attorney for the IC,  
13 having a reasonable basis to believe that Hisbay Haider Ali, M.D. (Respondent) violated the  
14 provisions of Nevada Revised Statutes (NRS) Chapter 630 and Nevada Administrative Code (NAC)  
15 Chapter 630 (collectively, the Medical Practice Act), hereby issues its Complaint, stating the IC's  
16 charges and allegations as follows:

17                   1.       Respondent is a medical doctor currently licensed in the State of Nevada by the  
18 Board in active-probation status (License No. 20660) since June 6, 2025. Respondent was  
19 originally licensed by the Board on December 31, 2020. Respondent's specialty is listed as  
20 psychiatry on the Board's website.

21                   2.       On May 7, 2025, Respondent entered into a global Settlement Agreement and  
22 Order with the IC to resolve Board Case Nos. 24-53587-1, 24-53587-2, and 24-53587-3 and the  
23 Board approved the agreement on June 6, 2025.

24                   3.       Per the terms of the Settlement Agreement, the Board entered its Order finding  
25 Respondent violated the Medical Practice Act, specifically, one (1) count of NRS 630.304(5),  
26 Influencing a Patient to Engage in Sexual Activity; one (1) count of NRS 630.301(5), Engaging in

1 Sexual Activity with a Patient; and one (1) count of NRS 630.304(7), Terminating Medical Care  
2 Without Adequate Notice to a Patient as alleged in Board Case No. 24-53587-1; one (1) count of  
3 NRS 630.301(4), Malpractice, and one (1) count of NRS 630.3062(1)(a), Failure to Maintain  
4 Proper Records as alleged in Board Case No. 24-53587-2; and two (2) counts of  
5 NRS 630.306(1)(l), Failure to Report Criminal Action or Conviction as alleged in Board Case No.  
6 24-53587-3.

7 4. Per the June 6, 2025, Settlement Agreement and Order, Respondent was ordered to,  
8 in pertinent part:

9 a. Reimburse the Board for the costs and expenses incurred in the  
10 investigation and prosecution of the above-referenced matters in the amount of sixty-two thousand  
11 eight hundred eleven dollars and seventy-six cents (\$62,811.76) by way of eighteen (18) monthly  
12 payments. The first six (6) payments shall be in the amount of one thousand dollars (\$1,000), the  
13 subsequent eleven (11) payments in the amount of four thousand seven hundred thirty-four dollars  
14 and thirty-one cents (\$4,734.31) and a final payment in the amount of four thousand seven  
15 hundred thirty-four dollars and thirty-five cents (\$4,734.35), with the first payment due on  
16 July 15, 2025, and every 15th of each month thereafter; and

17 b. Pay a fine of twenty thousand dollars (\$20,000) in eleven (11) equal  
18 payments of one thousand six hundred and sixty-six dollars and sixty-six cents (\$1,666.66) and a  
19 twelfth final payment in the amount of one thousand six hundred sixty-six dollars and seventy-  
20 four cents (\$1,666.74), with the first payment due January 15, 2026.

21 5. To date, Respondent has made six (6) timely payments toward the Board's costs  
22 and expenses in the total amount of six thousand dollars (\$6,000).

23 6. Board staff has been in contact with Respondent, through his counsel, requesting  
24 that he make the past due payments owed to the Board in the above-referenced cases.

25 7. Respondent's last payment to the Board was on June 6, 2025, for six (6) payments  
26 of one thousand dollars (\$1,000) toward the Board's costs and expenses.


