Operations

- Members were dropped for non-payment at the beginning of March, 150 unpaid members were dropped, list of these members have been circulated to the counties.
- Membership Renewals for the 2023-2024 invoicing year will be circulated on July 1st. The membership dues year is Oct. 1 – September 30th.
- The reoccurring/automatic renewal option on NSMA's database has been tested and is ready to go for the upcoming invoicing season.
- The American Medical Association (AMA) Annual Meeting will be held on June 9 – 14th in Chicago, Illinois. NSMA's AMA delegates, alternate delegates, and Interim Executive Director will be attending.

Specialty Management

- NSMA continues to manage the Nevada Orthopaedic Society (NVOS). They have quarterly board meetings that NSMA staffs. Preparation for these meetings includes preparing financial reports, membership reports, and Annual Meeting preparation reports. NVOS had their Spring Annual Meeting on May 11th in Las Vegas at Green Valley Ranch. There were over 11 vendors/sponsors in attendance along with 50 plus members from the Nevada Orthopaedic Society.

2023 Legislative Session

- The key issues that the association has been following during this legislative session are 1) GME 2) Medmal Increases 3) Scope Creep and 4) Medicaid Reimbursement
- Sarah, in conjunction with the Perkins Team organizes weekly specialty calls to review bills where there could be potential collaboration.
- Sarah, in guidance with the Perkins Team attends legislative committee hearings daily to testify on bills that the legislative core group has reviewed and provided direction on.
- 'Your Nevada Doctors' - Sarah attends these meetings as staff (takes minutes and circulates board packet documents), there are currently 6 NSMA members that are on the YND executive board.
- The association had its Physician's Day at the Legislature on April 4th. It was very well attended and there was a great line-up of programming which included the NSMA Executive Council meeting with the Governor, individual member/legislator appointments and the opportunity to sit on the Senate house floor.

- NSMA's Annual Meeting will be held in Stateline, NV this year at Harvey's Lake Tahoe Resort & Casino on August 25 – 27th.
