Notice of Workshop to Solicit Comments on Proposed Regulations

The Nevada State Board of Medical Examiners (Board), located at 9600 Gateway Drive, Reno, Nevada 89521, (775) 688-2559, is proposing a regulation pertaining to Chapter 630 of the Nevada Administrative Code (NAC). The public workshop has been set for **11:30 a.m. on Thursday, September 12, 2024**, at the Board's Las Vegas office located at 325 E. Warm Springs Road, Suite 225, Las Vegas, Nevada 89119, and video conferenced to the Board's Reno office located at 9600 Gateway Drive, Reno, Nevada 89521. The purpose of this workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

- R117-24** Authorizing by new provision, with certain exceptions, certain custodians of health care records electronically; prohibiting by new provision, with certain exceptions, a physician assistant from performing cosmetic surgeries without the direct supervision of a physician; amending NAC 630.155 and NAC 630.357 to authorize, with certain exceptions, the holder of a license to practice medicine or a license to practice as a physician assistant to receive additional credit for continuing education courses completed in certain specified areas; amending NAC 630.290, NAC 630.505, NAC 630.513, NAC 630.700, NAC 630.715, and Section 4 of LCB File No. R069-23 to revise the required contents of an application for a license as a physician assistant, practitioner of respiratory care, perfusionist, or anesthesiologist assistant; amending NAC 630.410 to say that the Board will send a copy of the order imposing discipline of a physician assistant to each supervising physician of the physician assistant; amending NAC 630.465 to make it clearer; amending Section 2 of LCB File No. R177-22 to clarify that a Board licensee must have a license that is in good standing in this State prior to supervising an advanced esthetician pursuant to the provisions in NRS Chapter 644A; repealing NAC 630.390 and NAC 630.545 because they are duplicative provisions; and providing other matters properly relating thereto.
