



CMS Increases Payments for Cognitive Assessments and Care Plan Services

Code accurately with the appropriate documentation to substantiate medical necessity.

“According to the [Alzheimer’s Association](#), “Alzheimer’s disease is the most common cause of dementia.” Most people appreciate that both Alzheimer’s disease and dementia have cognitive implications. What is the difference?

Dementia is an overall term for a particular group of symptoms, which include the following: difficulties with memory, language, problem-solving and other thinking skills involved in a person’s everyday activities. *Alzheimer’s disease* is the most common cause of dementia due to the brain changes.

The presence of toxic beta-amyloid and tau proteins is believed to activate immune system cells in the brain called microglia. Microglia try to clear the toxic proteins as well as widespread debris from dead and dying cells. Chronic inflammation may set in when the microglia can't keep up with all that needs to be cleared. Atrophy occurs because of cell loss. Normal brain function is further compromised in Alzheimer’s disease by decreases in the brain's ability to metabolize glucose, its main fuel. These brain changes are considered biomarkers of Alzheimer's.

Given that an estimated 12.7 million people over 65 years of age are projected to have Alzheimer’s by 2050, it is not surprising that the Centers for Medicare & Medicaid Services (“CMS”) evaluated its reimbursement for cognitive assessments and care plan services. [According to CMS:](#)

Effective January 1, 2021, Medicare increased payment for these services to \$282 (may be geographically adjusted) when provided in an office setting, added these services to the definition of primary care services in the Medicare Shared Savings Program, and permanently covered these services via telehealth. Use CPT code 99483 to bill for both in-person and telehealth services.

Why is this important for physicians and patients and what types of providers can conduct a cognitive assessment? First, cognitive impairment detection is a requirement of [Medicare’s Annual Wellness Visit](#). Second, medical providers such as physicians, nurse practitioners, physician assistants, and clinical nurse specialists may offer a cognitive assessment in a variety of locations (e.g., office/outpatient setting, private residence, care facility, rest home, and/or telehealth).

Nicola (Nick) M. Spirtos, M.D., F.A.C.O.G. and Carl N. Williams, Jr., M.D., FACS Join Board of Medical Examiners

Nicola (Nick) M. Spirtos, M.D., F.A.C.O.G. and **Carl N. Williams, Jr., M.D., FACS** were appointed by Governor Steve Sisolak to positions on the Nevada State Board of Medical Examiners (Board) effective September 1, 2021. The Board welcomes **Dr. Spirtos** and **Dr. Williams** as physician members.

Dr. Spirtos is a first-generation American whose family immigrated from Greece, and he is proud to say that there are three generations of physicians in his family. Dr. Spirtos holds a medical degree from Northwestern University. While at Stanford University (Fellowship in Gynecologic Oncology and Faculty 1985-2004), he was elected Deputy Chief of the Department of Obstetrics and Gynecology, served on the Executive Committee for Stanford University Hospital and had an Appointment as a Clinical Associate Professor. Dr. Spirtos established the Women's Cancer Center of Nevada, to bring oncologic services to women that had generally not been available locally. The Center now has a Division of Colorectal Surgery and a Division of Urogynecology in addition to providing gynecologic oncology care.

Dr. Spirtos has published approximately 100 peer-reviewed scientific articles, written multiple book chapters and reviews for multiple journals, and became the first American editor of Bonney's Textbook of Gynaecological Surgery. He led, as principal investigator, the Women's Cancer Center's research efforts, as one of approximately 50 primary research institutions (including world-renown cancer centers such as MD Anderson, Memorial Sloan-Kettering and Johns Hopkins) in the Gynecologic Oncology Group (GOG), a National Cancer Institute (NCI)-funded cooperative research group. The Women's Cancer Center was the first private practice ever admitted as a full member to the GOG. The GOG was the National Cancer Institute's only cooperative group, conducting clinical trials dedicated to the study and cure of gynecologic cancers. Dr. Spirtos has served the GOG as a member of virtually every significant committee within that organization, including overseeing the Quality Assurance Committee as Co-Chair and Chair for over 15 years. He served as the Co-Chair of the Surgical Oncology Committee of the newly formed NCI-sponsored cooperative group, NRG Oncology, a combined group of gynecologic oncologists, radiation oncologists, surgical oncologists, colorectal and breast surgeons.

Dr. Spirtos currently sits on the Membership Committee for the Gynecologic Oncology Group Foundation. He served as a member of the first University Medical Center Advisory Board, was Chair of the Quality Assurance Subcommittee, and served as a member of the University of Nevada, Las Vegas School of Medicine Community Advisory Board. He was recognized as a Distinguished Nevadan by the Nevada System of Higher Education (NSHE). Dr. Spirtos is interested in advancing medical science through properly run clinical trials and providing patients in Nevada with the opportunity to safely receive novel, cutting-edge medical care in addition to high-quality routine medical care.

Dr. Williams has been practicing medicine in Las Vegas for over 30 years. He holds a medical degree from Indiana University. He was the first African American Plastic Surgery Resident in Chicago (University of Illinois) and the first African American Plastic Surgeon in the State of Nevada. He brought the first laser center to Las Vegas and introduced a multitude of lasers and their functionality to the area.

Dr. Williams is triple board certified in plastic surgery, surgery of the hand, and otolaryngology. He has served on the board of directors of many different hospitals as both a leader of surgery and advanced wound healing. He was a member of the plastic surgery faculty for two years in Chicago, at the University of Illinois, and continues to pass on his knowledge today by continuing as a clinical educator for both the University of Nevada, Las Vegas School of Medicine and Touro University.

Dr. Williams holds active memberships in many professional organizations, including the AMA, ASPS, ASSH, and ASA. He is a Fellow of the American College of Surgeons and has volunteered for many medical missions to Mexico, Guatemala, Samoa, Costa Rica and the Philippines. He also participated in a medical exchange with China and Russia. Dr. Williams participated in a community outreach program that removed gang tattoos to give Las Vegas youth a chance to get out of that lifestyle. He has also contributed, as a reconstructive plastic surgeon, much needed assistance to victims of domestic violence. Dr. Williams established the Hand Surgery Department at University Medical Center hospital, and continues to take hand trauma call for four Las Vegas hospitals today.

NOTIFICATION OF ADDRESS CHANGE, PRACTICE CLOSURE AND LOCATION OF RECORDS

Pursuant to NRS 630.254, all licensees of the Board are required to "maintain a permanent mailing address with the Board to which all communications from the Board to the licensee must be sent." A licensee must notify the Board in writing of a change of permanent mailing address within 30 days after the change. Failure to do so may result in the imposition of a fine or initiation of disciplinary proceedings against the licensee.

Additionally, if you close your practice in Nevada, you are required to notify the Board in writing within 14 days after the closure, and for a period of 5 years thereafter, keep the Board apprised of the location of the medical records of your patients.

Finally, the subsequent visits and care plans should utilize the following codes:

In sum, this is an important clinical area that medical providers should not overlook. It is equally important for medical providers to code accurately with the appropriate documentation to substantiate medical necessity.

Legislative Update: 81st Session of the Nevada Legislature

Several bills were passed and sent to the Governor during the legislative session which may be of interest to the Board's licensees and the public.

[SB 5](#)¹ requires the Department of Health and Human Services to create an online data tool to collect information concerning access to telehealth and to evaluate polices and make access to healthcare more equitable, and expands the definition of "telehealth" to include audio-only interactions. SB 5 also maintains certain requirements concerning coverage of these services by insurers and third-party payers to cover telehealth to the same extent as other services, but excludes services provided through audio-only interactions for the purposes of industrial insurance.

[SB 184](#)² permits physician assistants who are licensed to work under an allopathic physician pursuant to NRS 630, or an osteopathic physician pursuant to NRS 633, to be licensed simultaneously under both Chapters of the Nevada Revised Statutes. Physician assistants may indicate on their application for licensure, or renewal, their intention to be simultaneously licensed. Simultaneous licensure requires application to both the State Board of Medical Examiners and the State Board of Osteopathic Medicine, and the payment of a reduced fee for licensure or renewal. SB 184 is in effect as of January 1, 2022.

[SB 196](#)³ prohibits providers of health care, or persons supervised by them, from performing pelvic examinations, if they are not appropriately licensed or certified to perform such an examination. This extends to examinations performed outside the scope of practice of the provider, and examinations that are performed on anesthetized or unconscious patients. The prohibition does not apply to an examination: (1) that is within the scope of a procedure for which the patient has given consent, (2) for diagnostic purposes where medically necessary when the patient is unconscious, or (3) performed as part of a forensic medical examination of a victim of sexual assault who is unconscious, and the exam is justified by exigent circumstances. SB 196 is in effect as of July 1, 2021.

[SB 211](#)⁴ requires certain providers of emergency medical services in a hospital or primary care to consult with patients aged 15 years or older as to whether they wish to be tested for sexually transmitted diseases. This requirement is excused if the patient is being treated for a life-threatening emergency, has recently been offered or undergone such a test, or lacks the capacity to consent to testing.

[SB 379](#)⁵ requires the Department of Health and Human Services to create a confidential online database to collect and analyze demographic and practitioner data to evaluate polices and increase access to healthcare. SB 379 amends Chapter 630 of the Nevada Revised Statutes to make a data request link available for the application, or renewal of a license, or a certification, and request each applicant to complete and submit the data request to the Department of Health and Human Services.

[AB 278](#)⁶ requires the Department of Health and Human Services to establish a database and make available to the Board of Medical Examiners a data request link for applicants to be included in the renewal of a license or biennial registration. AB 278 requires the Board to direct applicants to complete this data request. The request is offered to collect employment and practice details to analyze trends in employment and practices of physicians in the State of Nevada. AB 278 is in effect as of October 1, 2021.

AB 327⁷ requires licensees working as psychiatrists, or physician assistants practicing under the supervision of a psychiatrist, for their biennial registration, to complete continuing education of at least two hours relating to cultural competency, diversity, equity, and inclusion. AB 327 is in effect as of January 1, 2022.

AB 348⁸ transfers the Patient Protection Commission from the Office of the Governor to the Office of the Director of the Department of Health and Human Services. AB 348 requires members of the Commission to comply with disclosure requirements for conflicts of interest and to abstain from voting when such conflicts arise. The Commission is also designated as the sole state agency responsible for administering and coordinating the participation of Nevada in the Peterson-Milbank Program for Sustainable Health Care Costs, which provides technical assistance in developing targets for the reduction of per-capita spending on healthcare and helps analyze and address drivers of increasing healthcare costs.

AB 442⁹ requires a licensee who is authorized to prescribe controlled substances, as a condition of renewal of his or her license, on or after January 1, 2024, to complete at least two hours of training in the screening, brief intervention, and referral to treatment approach for patients with substance use disorders. This is defined as the utilization of an evidence-based method of delivering early intervention and treatment to persons who have, or are at risk of developing, a substance use disorder.

DISCIPLINARY ACTION REPORT

ALVAREZ, Jose H., M.D. (10765)

Henderson, Nevada

Summary: Alleged malpractice, failure to maintain appropriate medical records relating to his treatment of a patient, and engaging in conduct which the Board has determined is a violation of the standards of practice established by regulation of the Board.

Charges: One violation of NRS 630.301(4) [malpractice]; one violation of NRS 630.3062(1)(a) [failure to maintain timely, legible, accurate and complete medical records relating to the diagnosis, treatment and care of a patient]; one violation of NRS 630.306(1)(b)(2) [engaging in conduct which the Board has determined is a violation of the standards of practice established by regulation of the Board].

Disposition: On September 10, 2021, the Board accepted a Settlement Agreement by which it found Dr. Alvarez violated NRS 630.301(4), NRS 630.3062(1)(a) and NRS 630.306(1)(b)(2), as set forth in the Complaint, and imposed the following discipline against him: (1) public reprimand; (2) \$3,500.00 fine; (3) 5 hours of continuing medical education (CME), in addition to his statutory CME requirements for licensure; (4) reimbursement of the Board's fees and costs associated with investigation and prosecution of the matter.

BAARTZ, Louise M., RRT (RC3159)

Apple Valley, California

Summary: Disciplinary action taken against Ms. Baartz' license to practice respiratory care in California.

Charges: One violation of NRS 630.301(3) [disciplinary action taken against her license to practice respiratory care in another state].

Disposition: On September 10, 2021, the Board accepted a Settlement Agreement by which it found Ms. Baartz violated NRS 630.301(3), as set forth in the Complaint, and imposed the following discipline against her: (1) public reprimand; (2) reimbursement of the Board's fees and costs associated with investigation and prosecution of the matter.

BORROMEO, Salvador G., M.D. (8770)

Las Vegas, Nevada

Summary: Alleged engaging in conduct in violation of State Board of Pharmacy regulations, unauthorized and otherwise inappropriate prescribing of controlled substances, and failure to adequately supervise medical assistants.

Charges: One violation of NRS 630.306(1)(b)(3) [engaging in conduct which is in violation of a statute or regulation of the State Board of Pharmacy]; one violation of NRS 630.3062(1)(h) [fraudulent, illegal, unauthorized or otherwise inappropriate prescribing, administering or dispensing of a controlled substance listed in schedule II, III or IV]; one violation of NRS 630.306(1)(r) [failure to adequately supervise a medical assistant pursuant to regulations of the Board].

Disposition: On September 10, 2021, the Board accepted a Settlement Agreement by which it found Dr. Borromeo violated NRS 630.306(1)(b)(3), NRS 630.3062(1)(h) and NRS 630.306(1)(r), as set forth in the Complaint, and imposed the following discipline against him: (1) public reprimand; (2) \$5,000.00 fine; (3) reimbursement of the Board's fees and costs associated with investigation and prosecution of the matter.

BUTLER, Randy H., M.D. (6224)

Las Vegas, Nevada

Summary: Alleged engaging in conduct which the Board has determined is a violation of the standards of practice established by regulation of the Board.

Charges: One violation of NRS 630.306(1)(b)(2) [engaging in conduct which the Board has determined is a violation of the standards of practice established by regulation of the Board].

Disposition: On September 10, 2021, the Board accepted a Settlement Agreement by which it found Dr. Butler violated NRS 630.306(1)(b)(2), as set forth in the Complaint, and imposed the following discipline against him: (1) public reprimand; (2) \$1,500.00 fine; (3) 8 hours of continuing medical education (CME), in addition to his statutory CME requirements for licensure; (4) reimbursement of the Board's fees and costs associated with investigation and prosecution of the matter.

ESTEVEZ, Roger, M.D. (13199)

Las Vegas, Nevada

Summary: Alleged engaging in conduct in violation of State Board of Pharmacy statutes.

Charges: One violation of NRS 630.306(1)(b)(3) [engaging in conduct which is in violation of a statute or regulation of the State Board of Pharmacy].

Disposition: On September 10, 2021, the Board accepted a Settlement Agreement by which it found Dr. Estevez violated NRS 630.306(1)(b)(3), as set forth in the

Complaint, and imposed the following discipline against him: (1) public reprimand; (2) \$500.00 fine; (3) at least 8 hours of continuing medical education (CME), in addition to his statutory CME requirements for licensure; (4) reimbursement of the Board's fees and costs associated with investigation and prosecution of the matter.

FIFE, Douglas J., M.D. (13164)

Las Vegas, Nevada

Summary: Alleged malpractice, engaging in conduct which the Board has determined is a violation of the standards of practice established by regulation of the Board, and failure to maintain appropriate medical records relating to his treatment of a patient.

Charges: One violation of NRS 630.301(4) [malpractice]; one violation of NRS 630.306(1)(b)(2) [engaging in conduct which the Board has determined is a violation of the standards of practice established by regulation of the Board]; one violation of NRS 630.3062(1)(a) [failure to maintain timely, legible, accurate and complete medical records relating to the diagnosis, treatment and care of a patient].

Disposition: On December 3, 2021, the Board accepted a Settlement Agreement by which it found Dr. Fife violated NRS 630.306(1)(b)(2) and NRS 630.3062(1)(a), as set forth in Counts II and III of the Complaint, and imposed the following discipline against him: (1) public reprimand; (2) \$2,500.00 fine; (3) reimbursement of the Board's fees and costs associated with investigation and prosecution of the matter. Count I of the Complaint was dismissed with prejudice.

FUTORAN, Robert J., M.D. (5253)

Las Vegas, Nevada

Summary: Alleged failure to disclose a hospital investigation and suspension of his privileges at the hospital on his license renewal application.

Charges: One violation of NRS 630.304(1) [obtaining, maintaining or renewing a license to practice medicine by bribery, fraud or misrepresentation or by any false, misleading inaccurate or incomplete statement].

Disposition: On September 10, 2021, the Board accepted a Settlement Agreement by which it found Dr. Futoran violated NRS 630.304(1), as set forth in the Complaint, and imposed the following discipline against him: (1) public reprimand;

(2) reimbursement of the Board's fees and costs associated with investigation and prosecution of the matter.
